With continuing changes in healthcare and a growing demand for high-quality, cost-effective care for our nation's diverse populations, the EMS profession needs a strong, energetic and inclusive professional organization more than ever.

2016 was a year of great

accomplishments for our association. NAEMT led efforts to educate the EMS profession about the increasing importance of data through two national survey reports - one on the collection, use and exchange of EMS data, and another, conducted in collaboration with St. Louis University, on the usability of electronic patient care reports (ePCR) systems.

We raised awareness about a critical issue facing our workforce - EMS mental health - through articles and a national survey report. The survey revealed a pervasive sense throughout EMS that we need additional mental health support and services to help us cope with the inherent stress of the work we do. And we continued to lead the national dialog on the transformation of our profession to EMS 3.0, through the publication of learning tools and hosting the EMS Transformation Summit in conjunction with EMS On The Hill Day.

2016 also saw major strides in advancing the EMS profession and supporting quality improvement in patient care through advocacy. The Veteran EMT Support Act was signed into law, while the Protecting Patient Access to Emergency Medications Act gained substantial momentum. We look forward to continuing to build on that in 2017.

Another major area of focus for NAEMT is providing the world's highest quality, most engaging and up-to-date continuing education for EMS professionals. Our esteemed authors continued to produce the best continuing education for EMS professionals available anywhere, with the release of the 2<sup>nd</sup> editions of Advanced Medical Life Support (AMLS) and EMS Safety, and the 3<sup>rd</sup> edition of Emergency Pediatric Care. New courses were also introduced - All Hazards Disaster Response and Advanced Geriatric Education for EMS, to name a few.

And that's not even close to everything! I'm amazed when I look back on the year and see how much was accomplished through the dedication of our volunteer leaders - board members, committee members, and education, advocacy, and membership coordinators - who give so much of their time, energy and expertise.

I also thank you, our members, whose support makes everything possible. We're grateful that you choose to be a member of your professional organization. # NAEMT Advocacy

The purpose of NAEMT's Advocacy program is to represent our members on issues that impact the EMS work environment and the ability of EMS practitioners to care for their patients. Through advocacy, NAEMT helps ensure that the EMS perspective is understood and incorporated into the policies, plans and programs of our government.

#### **2016 ADVOCACY PRIORITIES**

## The Veteran EMT Support Act

H.R. 1818/S. 453

On July 23, the Veteran Emergency Medical Technician Act of 2016 was signed into law as part of a larger bill, the Comprehensive Addiction Recovery Act (CARA). This was a huge win for the EMS community!

The Veteran EMT Act assists military medics in transitioning into civilian EMS jobs by streamlining the process for veterans and separating military personnel to meet state certification and licensure requirements. Thanks in large part to the strong advocacy of NAEMT members, H.R. 1818 was included in the larger CARA bill, which addresses the nation's opioid addiction and overdose epidemic. In addition, one section of CARA calls for grants for training first responders in administering drugs such as naloxone to reverse opioid overdoses.

## Protecting Patient Access to Emergency Medications Act

H.R. 4365/S. 2932

Another bill that picked up momentum in 2016 is the Protecting Patient Access to Emergency Medications Act, which allows EMS to continue to administer narcotic pain and anti-seizure medications using standing orders from a physician. The legislation has broad support throughout EMS, emergency medicine, law enforcement and public safety communities. In March, NAEMT kicked off a highly successful advocacy campaign during which our members and other EMS professionals sent 2,700 messages to members of Congress asking for their support. By the end of the campaign, the bill had 77 co-sponsors and a Senate companion bill had been introduced! In November, the bill passed in the U.S. House of Representatives.



# The Field EMS Modernization and Innovation Act

H.R. 2366

NAEMT continued to educate members of Congress about the vital role of EMS, EMS innovations such as mobile integrated healthcare and community paramedicine, and the need for payment reform to recognize EMS as a healthcare provider rather than solely as a transportation provider. Though the bill had difficulty gaining traction in 2016 during the run up to the presidential and Congressional elections, advocating for the bill helped us immensely in our efforts to make sure members of Congress and key stakeholders better understand what EMS is, what we do and the challenges we face in ensuring we have the resources to fulfill both our traditional mission as providers of emergency medical services and our evolving mission as a key elements of the healthcare continuum.

## National EMS Memorial

H.R. 2274

NAEMT was proud to support the establishment of a National EMS Memorial in Washington, D.C., to honor EMS practitioners killed in the line of duty. The bill seeks Congressional authorization to establish the memorial on federal lands. Funding would come from donations.

A special thank you to NAEMT's Advocacy Committee and Advocacy Coordinators! These dedicated NAEMT members are crucial to educating and informing elected officials, their EMS colleagues, the public and other stakeholders about the value of EMS and the need to support legislation helping EMS fulfill its mission.

## Advocate of the Year Award

In 2016, NAEMT recognized two outstanding advocates - Mark Babson of Idaho and Leroy Garcia of Colorado. Both are individuals whose tireless efforts on behalf of EMS have helped to bring about important legislation advancing our profession!

Babson was instrumental in getting a bill passed in his state establishing community paramedic as a distinct healthcare provider, paving the way for reimbursing EMS for transporting patients to alternative destinations.

Garcia is a state senator, EMS educator and paramedic for American Medical Response. Garcia has sponsored bills establishing Colorado's critical care paramedic program; providing emergency responders with additional protection from testifying about information shared during peer support; and enhanced penalties for assaults on EMS practitioners.



### Legislator of the Year Award

EMS needs its champions in Congress who are committed to supporting high quality EMS. In 2016, we were thrilled to have Sen. Bill Cassidy (R-La.) as recipient of the EMS Legislator of the Year Award. Cassidy, a physician, introduced the Veteran EMT Support Act in the Senate in 2015 and the Senate version of the **Protecting Patient Access to Emergency** Medications Act in 2016.



# Focus On Data

Data is becoming a critical component of healthcare, including EMS. Quality data is needed for EMS to make evidence-based treatment decisions, to analyze safety and effectiveness and to conduct quality improvement. As healthcare shifts from a volume-based to a value-based system, EMS will need to have data that shows EMS positively impacts patients' health relative to cost - and is therefore worth paying for. In 2016, NAEMT was a leader in exploring the current state of data in EMS and educating the EMS community and stakeholders about the importance of data.



## National Survey on Data Collection, Use and Exchange in EMS

More than 2,400 EMS practitioners, managers, data managers and medical directors from a wide variety of agency sizes and types responded to our survey on EMS data. The survey revealed that while data is becoming more important in EMS, there are significant obstacles at the practitioner, agency and healthcare system level. The report was published in July.



## ePCR Usability Survey

NAEMT commissioned Dr. Alex Garza of St. Louis University College for Public Health and Social Justice to conduct a survey and research to identify how EMS practitioners interface with the software systems they use on the job. The report reveals how usable EMS practitioners find common electronic patient care reporting (ePCR) systems and will be used to inform ePCR vendors about areas of strength and in need of improvement. The report was distributed to members and widely throughout EMS in January 2017.


# Supporting the Transformation of EMS


The days of "you call, we haul" are fast fading into the past. Through EMS's important contributions to stroke, cardiac and trauma systems of care, EMS is far more likely to be seen as an important part of the healthcare continuum. Through the development of mobile integrated healthcare and community paramedicine (MIH-CP), EMS innovators are also demonstrating the ways in which EMS can intervene with some of healthcare's most expensive, difficult to manage patients. NAEMT is a leader in helping the EMS workforce and stakeholders understand and identify the opportunities in the

NAEMT created two infographics (one for an EMS audience and one for outside stakeholders), as well as a PowerPoint presentation, to educate EMS professionals and the wider healthcare community/policymakers about EMS 3.0.







## EMS 3.0 Transformation Summit

Held in conjunction with EMS On The Hill Day, the EMS 3.0 Transformation Summit drew nearly 200 attendees for a day of presentations and panel discussions with nationally recognized EMS leaders and physicians, as well as representatives from insurance companies and the National Committee on Quality Assurance (NCQA).

# Promoting EMS Workforce Safety and Resiliency

The emotional and psychological toll of a career in EMS has emerged as a major concern for the profession. There are multiple reasons why so many EMS practitioners report struggling with issues such as depression and post-traumatic stress disorder (PTSD). Contributing factors include witnessing horrific situations, the threat of on-the-job violence, even the strain of shift work and not getting adequate sleep. EMS professionals face other risks to their health and safety as well – such as motor vehicle collisions and exposure to pathogens or infectious disease.

NAEMT has taken a leading role in understanding and seeking solutions for the issues that impact EMS workforce safety and resiliency.



## NAEMT Report: Patient Safety in EMS

In November 2016, NAEMT published a report that explored the potential role of patient safety organizations (PSOs) in EMS. PSOs allow healthcare organizations and personnel to report and collect data on adverse safety events, while protecting them from having that used against them.





### National Survey on EMS Mental Health Services

NAEMT's 2016 National Survey on EMS Mental Health Services struck a chord with EMS practitioners. More than 2,200 responded to questions assessing the availability of mental health resources at our nation's EMS agencies, how likely EMS practitioners are to use them, and barriers to receiving support. Some of the most revealing insights came from responses to an open-ended question on the state of EMS mental health services. More than 500 respondents offered their thoughts and feelings, with many sharing their own struggles and others indicating EMS mental health is an urgent issue that deserves to be addressed more fully.

# Comments, Position Statements and Other Activities

In 2016, NAEMT published the following position statements addressing EMS workforce issues.

## Position Statement: Discrimination in the Workplace

Patients and practitioners are entitled to give and receive care in an environment free of discrimination, according to a position statement drafted by the EMS Workforce Committee and adopted by the Board of Directors in August.

# Comment to Department of Labor on Classifying EMTs, Paramedics

NAEMT drafted comment to the U.S. Department of Labor urging changes to how it classifies EMS professionals for statistics gathering purposes. The current system has led to an undercounting because firefighter-EMTs and firefighter-paramedics are often listed as firefighters only. This comment was endorsed by 14 member organizations of the Joint National EMS Leadership Forum, of which NAEMT is a member.

# Comment on the EMS Agenda for the Future

With the EMS Agenda for the Future undergoing a revision, NAEMT submitted comment to the National Highway Traffic Safety Administration (NHTSA) and the Federal Interagency Committee on EMS (FICEMS). NAEMT board members, committee members and subject matter experts submitted a detailed outline of the most critical issues facing EMS, the most significant changes that have occurred over the past two decades and the changes ahead that EMS should prepare for. Originally published in 1996, the agenda created a vision, strategic plan and needs assessment for the development of EMS.

#### **EMS WEEK PARTNERSHIP**

NAEMT continued its partnership with the American College of Emergency Physicians (ACEP) on the EMS Strong campaign, which encourages the celebration of EMS each May. The 2016 theme was "Called to Care."

# EMS Safety OFFICER PROGRAM

During EMS World Expo, NAEMT partnered with the other 11 member organizations of the National EMS Safety Council to offer the EMS Safety Officer Workshop. This half-day session was designed for EMS practitioners who serve as their agency's designated safety officer or who seek to qualify for this position. The workshop covered how to measure safety, the use of checklists to promote safety, how to recognize and handle behavioral health issues in employees, meeting OSHA infection control training requirements, and driver education and training.

# NAEMT Education Courses

# Offering Timely, Engaging and Evidenced-Based Content

NAEMT Education continued its strong growth trend, with the number of students taking NAEMT courses reaching 74,199 in the U.S. and 20,567 internationally. NAEMT courses are now offered in 64 countries – making our education program truly a global endeavor!

The mission of NAEMT Education is to improve patient care through high quality, cost effective, evidence-based education that strengthens and enhances the knowledge and skills of EMS practitioners. To help us continue to reach that goal now and in the future, in 2016, the NAEMT Board of Directors implemented changes to the education committee and administrative structure.

The board determined the structure that had been in place since the 1990s needed to be modernized to reflect the tremendous growth of the education programs over three decades and overall shifts in how EMS education is developed and delivered.

The success of NAEMT Education is made possible by the members of our education program committees and course authors, who contribute countless hours to develop the finest EMS curriculum available. We also extend our deep gratitude to our Affiliate Faculty, and State, Provincial, Regional and National Educational Coordinators!



#### **KEY CHANGES**

- Bringing all trauma and tactical care courses under one Prehospital Trauma Committee (PHT).
- Appointing a new network of State Education Coordinators in the United States to build awareness and support for NAEMT education within each state, the District of Columbia and Puerto Rico, and support the work of EMS training centers offering NAEMT courses.
- Appointing Regional Education
   Coordinators in each of the four
   NAEMT regions to oversee the work of the State Education Coordinators.
- Waiving the standard requirement for Affiliate Faculty monitoring of new faculty for CAAHEP accredited training centers.



## For Instructors

The NAEMT Instructor Preparation Course continues to provide a thorough yet affordable means to prepare instructors to teach NAEMT courses. In 2016, 3,724 EMS instructor candidates took the course, which is offered online in English and Spanish, and as a classroom course in other languages.



# **NEW** NAEMT Education Courses

In 2016, NAEMT developed three new continuing education courses that address urgent and timely issues related to patient and workforce safety and resiliency, including preventing psychological trauma in patients, safe vehicle operations and preparing for mass casualty situations.

Psychological Trauma in EMS Patients (PTEP)

Patients who have suffered a serious injury or illness, or who have experienced a terrorist attack or natural disaster, can have

attack or natural disaster, can have more than physical scars. Fear, stress and pain can result in psychological trauma. NAEMT, in collaboration with LaGuardia Community College in New York City, developed Psychological Trauma in EMS Patients (PTEP) to provide EMS practitioners with the tools to help alleviate patients' hidden wounds. This new course was developed with funding from the Northeast Resiliency Consortium.



EMS Vehicle Operator Safety (EVOS)

Every year, 33 people die and 2,600 are injured nationwide as a result of ambulance

crashes. EMS Vehicle Operator Safety (EVOS) focuses on the specific behaviors needed to create a culture of safe driving. The course features case studies and analyses of common and catastrophic collisions. While other vehicle operator courses tend to focus primarily on driving and technical skills, this course challenges EMS practitioners to reconsider their preconceptions about safe vehicle operations.

All Hazards Disaster Response (AHDR)

Floods, tornadoes, earthquakes, bus wrecks, active shooters, terror attacks – All Hazards

Disaster Response teaches EMS professionals to analyze potential threats in their area, assess available resources, and create a response plan that will save lives. Each participant creates a "hazards vulnerability analysis" to assess the incidents most likely to occur in their geographic region, the location of their most vulnerable community members (such as nursing homes and hospitals), and the availability of resources to respond. The course culminates with a largescale mass casualty activity. Fifty-five students participated in a beta-test of the course in New Orleans in fall 2016.



### Advanced Medical Life Support (AMLS)

**Courses:** 1,315 **Students:** 16,249

AMLS is the EMS industry's gold standard in education for prehospital assessment and treatment of medical conditions often encountered by EMS practitioners. AMLS teaches critical MAENT

thinking skills to evaluate patients and determine a list of possible diagnoses that guide treatment decisions.

2016 was the first full year the new 2<sup>nd</sup> edition textbook and course materials were available. The 2<sup>nd</sup> edition features 100 exciting new scenarios in a highly interactive format. Throughout the year, NAEMT worked to dispel the mistaken belief that AMLS is only for paramedics. AMLS benefits EMTs as well! This was a contributing factor to the solid growth of this course in 2016. AMLS was also offered as a two-day preconference workshop at EMS World Expo in October.

## **EMS Safety**

Courses: 252 Students: 2,284

With on-the-job safety for EMS practitioners garnering more attention nationally, NAEMT was pleased to offer the only comprehensive, national safety-focused education course for EMS



professionals. Its interactive format features real-life case studies, compelling discussions on current safety issues, and provides participants with a forum to share their own experiences. EMS Safety educates EMS practitioners about risks they face from patients, members of the public and on the roadways, with the goal of reducing injuries and deaths.

## Emergency Pediatric Care (EPC)

Courses: 392 Students: 4,289

As critically ill and injured children make up a small fraction of the patients EMS responds to on a day-to-day basis, there is a strong need for EMS practitioners to regularly review and practice response



protocols and skills to ensure their readiness when needed. EPC continued its steady growth in 2016 with the 3<sup>rd</sup> edition, encompassing lectures, interactive skills stations, small group critical thinking discussions and patient simulations/ resuscitation scenarios.



## Geriatric EMS (GEMS)

Courses: 358 Students: 3,334

The number of older adults in the United States and abroad is growing rapidly. GEMS helps EMS practitioners develop the skills and knowledge to take care of geriatric patients' unique health



and communications challenges. In 2016, NAEMT's GEMS Committee, made up of EMS educators, field practitioners experienced in caring for the elderly, and nationally recognized experts in emergency medicine and geriatrics, completed the development of the GEMS Advanced course. Building on NAEMT's GEMS core course, GEMS Advanced delves deeper into the medical, social, and environmental challenges that EMS practitioners will encounter when responding to geriatric patients. An interactive, immersive educational format that focuses on integrating critical thinking into real-world applications, GEMS Advanced was beta-tested to an enthusiastic group at EMS World Expo.

# Principals of Ethics and Personal Leadership (PEPL)

Courses: 34 Students: 268

Whether entering people's homes when they are sick and vulnerable or responding to potentially volatile and unpredictable scenes, EMS personnel benefit from strong ethics, the ability to



communicate effectively in highly stressful circumstances and conflict resolution skills. PEPL explores the personal and professional values, leadership skills and communications strategies that EMS practitioners rely on for decision-making and interacting with patients and their families, other medical personnel, co-workers, supervisors and the public. In 2016, the PEPL Committee reviewed and revised the process for becoming a course instructor to reduce the obstacles to teaching the course, and developed an outline for a one-day online component for the course to be published in 2017.





### Prehospital Trauma Life Support (PHTLS)

**Courses:** 3,995 **Students:** 45,740

PHTLS was developed in 1983 by the late Dr. Norman McSwain, a renowned trauma surgeon who was beloved by the EMS and trauma care communities.



PHTLS promotes critical thinking in responding to and treating seriously injured patients. These time-critical decision-making and clinical skills are used every day throughout the U.S. and the world by EMS practitioners to save lives. With a curriculum developed by a group of renowned physicians, EMS educators and EMS practitioners, in cooperation with the American College of Surgeons Committee on Trauma, PHTLS offers the highest quality trauma education for EMS practitioners available.

Over 230 students also took PHTLS for First Responders, a version of PHTLS tailored to first responders such as police, firefighters, rescue personnel and safety officers to render care to trauma patients until EMS personnel arrive.

#### **NEW PHT COMMITTEE ESTABLISHED**

In 2016, to prepare for the 9<sup>th</sup> edition, NAEMT established a new Prehospital Trauma Committee. This new committee became responsible for developing all of NAEMT's trauma course materials, including PHTLS as well as the tactical trauma courses. The committee conducted surveys of PHTLS students and instructors regarding the 8<sup>th</sup> edition of PHTLS in preparation for the development of the 9<sup>th</sup> edition to commence in 2017.

## Tactical Emergency Casualty Care (TECC)

Courses: 318 Students: 4,236

Introduced in 2015, TECC teaches EMS practitioners the skills to provide medical care in mass casualty situations, where available resources can become quickly overwhelmed and practicing



scene safety is crucial. Focusing on hemorrhage control, surgical airway control and needle decompression, drag and carry techniques and taking care of patients when under direct and indirect threats, TECC offers a new focus for EMS training and preparation that has never been more timely or important. TECC was offered as a two-day preconference workshop at EMS World Expo.

STECC takes the TCCC program that has saved countless lives in the military and adapts it to the civilian world. If you read the front page of the newspaper, it's clear that this type of training is important for our crews in our current world.

## Tactical Combat Casualty Care (TCCC)

Courses: 487 Students: 6,758

Using curriculum developed by the U.S.
Department of Defense Committee on
Tactical Combat Casualty Care (CoTCCC),
TCCC teaches military personnel the
latest evidence-based techniques for
treating life-threatening trauma on the battlefield. TCCC
covers delivering care under fire, airway management, bleed
control, resuscitation and pain relief.

TCCC-Medical Personnel is for all military medical personnel who are preparing to deploy in support of combat operations. TCCC-All Combatants covers basic life-saving skills for non-medical military personnel. While other groups may offer TCCC training, TCCC as offered by NAEMT is the only course endorsed by the American College of Surgeons.

# Law Enforcement and First Response Tactical Casualty Care (LEFR-TCC)

Courses: 448 Students: 7,113

Often, police are the first to arrive at the scene of a motor accident or an active shooter. LEFR-TCC teaches law enforcement officers to take action to save a life with basic airway management and bleed control techniques.





# Bleeding Control for the Injured (B-Con)

Offered in partnership with the American College of Surgeons, B-Con is a 2.5-hour course that teaches civilians bleed control techniques that

can buy time until emergency care arrives. The curriculum is available to NAEMT instructors at no charge. Instructors are urged to teach the class, as a public service, to their communities.







# Working to Increase Membership


