EMS Makes a Difference for Millions of Americans, Yet Needs Greater Federal Support:

- EMS provides services for a wide range of emergency medical conditions (including trauma, stroke and cardiac) from answering 9-1-1 calls, first response, field medical response, medical transport, hospital treatment and rehabilitation.
- EMS <u>saves lives</u> and is a unique and critical part of the healthcare delivery system. EMS is a public benefit provided by both governmental and non-governmental providers that citizens assume will always be there to serve them.
- EMS providers and practitioners in the "field" conduct nearly 25 million transports for more than 8% of the US population per year, predominantly by ground but also by air, to hospitals and trauma centers as part of the emergency and trauma care continuum.
- Multiple authorities including the IOM, NHTSA, FICEMS, and NEMSAC have described
 the difference that EMS makes for patients. The IOM has noted major challenges facing
 the EMS and trauma care systems, including with regard to preparedness and response,
 evidence based care, quality, coordination and accessibility of emergency medical and
 trauma care and transport, particularly in rural areas.
- Despite the growing body of evidence documenting the value of emergency medical care in improved patient outcomes and/or cost-effectiveness for heart, stroke, and respiratory emergencies, as well as pediatric and trauma care, EMS and trauma care remains significantly underfunded and are severely challenged to best serve patients.
