In July, the National EMS Memorial Service was held in Arlington, Virginia, to recognize and honor the sacrifices of the 2023 honorees who died in the line of duty. Representatives from the NAEMT Board attended the Service to honor our fallen and their families.

### [slide: Annual Report series]

And now, I am pleased to provide an update on the work that has been accomplished on behalf of our members and to advance our profession. It's been a very busy year and we still have over 3 months to go. First, let me share with you the highlights of our advocacy work. Through our efforts:

- The Supporting and Improving Rural EMS Needs (SIREN) Reauthorization Act was introduced in the <u>Senate</u> and the House and we are on track to see this very important grant program receive congressional reauthorization.
- The EMS Counts Act of 2023 was introduced in the <u>House</u> and <u>Senate</u> to require the Department of Labor to accurately count the number of EMS personnel in the country.
- Letters were sent to <u>Senate and House leaders</u> to ask for EMS workforce development funds for EMS agencies. And, we submitted comments to the Senate and House leadership on the need for federal help to address the EMS workforce shortage and to ensure that EMS personnel receive the disaster preparedness training that they need to effectively respond to the increasing number of disasters.
  - EMS On the Hill Day was held on March 30 at which 240 EMS professionals from 39 states and the District of Columbia participated in 217 meetings with their members of Congress and staff to discuss our key legislative requests. We appreciate the efforts of all who were able to walk the halls of the Capitol with us.
  - A letter was sent to the Secretary of Health and Human Services and the CMS Administrator to express our deep disappointment in their decision to terminate the ET3 Model on December 31, 2023, two years before the originally scheduled date for the end of the pilot project.
  - Another letter was sent to the Ground Ambulance Payment Billing Advisory Committee recommending that the committee ask Congress to require commercial insurers to adequately reimburse ambulance

services to eliminate the need for balance billing, and that interfacility transfers be regulated differently than 911 ambulance services, which operate under a different financial model.

- A joint letter was sent to the Secretary of Veterans Affairs to request a delay in implementation of the
  final rule on changes in the rates that the VA pays for ambulance services, and a meeting with the
  Secretary and his staff to discuss how the VA and EMS can work together during the delay to help ensure
  that veterans can continue to receive ambulance services.
- Member advocacy campaigns were conducted this year to generate support in Congress for our legislation. The eight campaigns resulted in 5,590 emails sent to 428 members of Congress. Thank you to all members who participated in these campaigns!
- The results of a <u>national survey</u> on how EMS economic and operational models have been changing in the face of unprecedented challenges were published.
- The results of our <u>national survey on MIH-CP programs</u> were also published.
- The 49th <u>National EMS Week on May 21-27</u> was promoted across the country. This year's theme, EMS:
   Where Emergency Care Begins, highlighted the important contributions of EMS practitioners in
   safeguarding the health, safety, and well-being of our communities.
- Three new position statements on key issues were adopted calling for:
  - 1. State Medicaid reimbursement for EMS that covers the actual cost of response.
  - For the federal government to establish an <u>Emergency Support Function (ESF) specifically for</u>
     <u>EMS</u> within the National Response Framework, decoupling EMS from ESF #8, Public Health and
     Medical Services.
  - And, for the level and quality of <u>participation by EMS in DHS fusion centers</u> to be standardized across the nation to ensure that fusion centers have consistent access to information and intelligence collected by EMS.
- A new page was created on the NAEMT web site to provide <u>EMS workforce development resources</u> to members and four <u>scholarships</u> were awarded to help students in underrepresented groups to enter the EMS workforce.

We have been working hard to provide our members with more benefits and services to support their careers and improve their health and well-being.

- <u>NAEMT Radio</u>, our latest initiative to inform and engage members, made its debut in February. Podcasts are
  published twice a month on trending topics presented by the top leaders and subject matter experts in EMS.
- The 2024 class of <u>Lighthouse Leadership</u> mentees was selected, joining the first class selected in 2023. Created for our members, the program is designed to match mentees with mentors who can guide and support them in achieving their leadership goals.
- Two NAEMT members were awarded and accepted <u>scholarships</u> to advance their careers. The application period for our next round of scholarships just ended and those recipients will be notified next month.
- Free webinars with CE credit were offered to members on
  - changes to EMS economic and operational models,

- best practices in coordinating education courses,
- navigating CMS compliance with Medicaid supplemental payments,
- prehospital stroke assessment and treatment,
- cybersecurity readiness and response,
- prehospital trauma standards of care,
- preparing your EMS comms system for disaster response and recover,
- extreme weather impacts on first responders and patient care, and
- lessons from the first round of Medicare cost data collection.

More free webinars will be offered throughout the remainder of the year.

- In gratitude for their service, a raffle was conducted each day during EMS Week for full NAEMT members in the U.S. Multiple gifts were distributed, with winners announced on the EMS Week <u>Raffles and Discounts</u> page of the NAEMT website. And this month we are raffling off products to members for National Preparedness Month.
- To help our members understand and access all of the benefits that come with NAEMT membership, the Membership Monday's newsletter was launched in June. Each monthly issue highlights a selection of benefits, explaining what members receive and how to access them.
- Virtual listening sessions were held in February with our Board members so that members could share their
  needs, interests, and concerns regarding EMS and NAEMT. And, next month, we will open up our virtual
  committee meetings to all members so that they can learn about the projects that our committees are working
  on.
- We are working on the development of a new mobile app for our members to notify you of NAEMT courses in your local area, advocacy alerts, limited time discounts, your membership status, and easy navigation to your NAEMT member benefits. This new app will become available in the Spring of 2024.

We continue to develop some of the best education curricula for EMS practitioners to strengthen their knowledge and skills.

- The 10th edition of our PHTLS <u>course</u> was published earlier in the year. It's a fantastic course and I encourage all members to take PHTLS to refresh and enhance your trauma response.
- NAEMT's Mental Health Resilience Officer (MHRO) course was published in an 8-hour classroom format, in addition to the previously released online format. This is an important course that assists EMS agencies in building and supporting the mental health resilience of their personnel.
- Three additional courses in our <u>Community Paramedicine Series</u> were published: Endocrine Disorders, Cardiac Disorders, and Respiratory Disorders. These courses teach participants working as community paramedics how to care for patients diagnosed with chronic cardiac, endocrine and respiratory illness.

- The 3rd edition of Geriatric Education for EMS has just published. It includes a new course schedule, and all new lessons and patient simulations. The first official 3<sup>rd</sup> edition course was conducted today right here in New Orleans.
- Development of the 2<sup>nd</sup> edition of All Hazards Disaster Response has been completed and the first official 2<sup>nd</sup> edition All Hazards course was held yesterday here at EMS World Expo. The 2<sup>nd</sup> edition course materials will be available for training centers early in 2024.
- A new online EMS Safety Officers course has been developed and will publish by the end of the year. This new course helps prepare EMS personnel to serve as their agency's EMS Safety Officer.
- Congratulations to our AMLS Committee for the 4th edition AMLS Instructor Update, which was held on Monday. This committee has been hard at work revising and editing the AMLS textbook, updating the course schedule, and writing the course lessons and patient simulations. We deeply appreciate all of the committee's work to ensure that this 4<sup>th</sup> edition of AMLS is outstanding.
- And congratulations to Drs. Warren Dorlac and Meg Morgan for leading the <u>12th annual World Trauma</u>
   <u>Symposium</u>. Once again, the Symposium presented a lineup of the very best experts in prehospital trauma to a global audience. Thank you for your leadership of this world-class event.

Staff Sergeant Clerkin sets himself apart as a special operations medic, flight medic, and leader. Over the past 12 months, Staff Sergeant Clerkin has been deployed to two locations for greater than 90 days.
