## **Shirley Terry (NEMSMA)**

- Executive Director for the Mile High RETAC it's part of the State trauma system

-Work closely with EMS, Fire, and Hospital Physicians and Nurses.

-Organize 15-year Annual National EMS Safety Summit and Financial Symposium April 4-7, 2023 -pre-conference AAA workshop on cost reporting for Medicare, since a lot of agencies must report by May.

-National Ems Safety Summit for April 5-7 Safety Summit will have some great speakers at this big conference with in-person attending only.

## Dave Bryson (NHTSA OEMS)

-50% more highway safety funding in year 2 of 5 covering from section, had been used for 402 state assessment AED, EMS Programs, & 405 and state data stop the bleed kits and AEDs. https://www.transportation.gov/grants/SS4

-NESMSO cap pediatric safety in ambulance through NASEMSO STC group with a 5-year plan.

-CAP-5 was awarded in 4-days as Phase 1, test methods for 3-SAE guidelines standards for supine pediatrics, seated pediatrics, and neonatal.
