FROM THE PRESIDENT

Each year, the NAEMT Annual Report provides an opportunity to look back at the work and accomplishments of our association. As this report arrives in your inbox, the EMS profession is facing one of the greatest challenges since its inception. COVID-19 has upended our expectations about what 2020 would bring, and has created unprecedented difficulties for EMS practitioners, agencies and communities.

EMS practitioners, as they have been during so many crises, are on the frontlines of the battle against this pandemic. Day and night, EMS practitioners are demonstrating incredible bravery and compassion as they come to the aid of sick and frightened patients. They are innovating to find solutions to shortages of PPE and other resources, pulling together to support their colleagues in coping with the stress of COVID-19, and demonstrating their strength, skill and dedication to serving the most vulnerable members of the community.

As I look back at the work of NAEMT from the past year – and look to the challenges that are ahead – I am struck by how vital and necessary our mission is now and in the months and years to come.

In 2019, our legislative priorities focused on securing resources to support EMS in providing excellence in patient care and protecting our workforce. Notable successes included passage of the Supporting and Improving Rural EMS Needs (SIREN) Act, the Volunteer Responder Incentive Protection Act and the Pandemic and All-Hazards

Preparedness and Advancing Innovation Act (PAHPA). PAHPA contains provisions to strengthen trauma response through military-civilian partnerships and Good Samaritan protections for EMS and other healthcare workers helping the victims of disasters.

Our education initiatives continued to build on our longstanding commitment to ensuring EMS practitioners have access to the highest quality education and training. Publishing the 9th edition Prehospital Trauma Life Support (PHTLS) course materials in English and Spanish, the 2nd edition of Tactical Emergency Casualty Care (TECC), and conducting the instructor update for the 3rd edition of Advanced Medical Life Support (AMLS) were three of the year's highlights. NAEMT instructors also taught a record number of students, while the number of approved NAEMT training centers continued to grow around the world.

We also worked to keep our EMS workforce informed and up-to-date on a range of important topics through numerous educational events, workshops and webinars. From the EMS Transformation Summit to the 8th annual World Trauma Symposium to the EMS Finance webinar series, NAEMT strove to help EMS practitioners prepare to meet the challenges of an evolving healthcare environment and an unpredictable world.

COVID-19 is a stark reminder of just how unpredictable our world can be. As our profession's largest and most diverse membership association, NAEMT must

reaffirm our commitment to fighting for funding and resources that enable EMS practitioners to serve the community, safely and to our fullest potential.

We must continue to bang on the doors of members of Congress and ensure they are aware of the essential role of EMS throughout our nation, during the COVID-19 pandemic and during the other medical emergencies, traumas and mass casualty incidents that will continue to occur, long after the pandemic is over. We must make sure that the public, our colleagues throughout healthcare, and all stakeholders understand EMS contributions to the health and safety of our nation.

We must ensure EMS practitioners have the best, most timely and most relevant education and training to face all of the circumstances and situations that arise. And we must help our EMS colleagues have the information they need to adapt to changing conditions, to keep themselves and their families safe, and to feel appreciated and supported as they help their communities overcome – and ultimately prevail – over this crisis and others.

I am deeply honored and humbled to be serving our association as President. I am joined by all the members of the NAEMT Board of Directors in our commitment to do everything possible to support you during and beyond this pandemic.



NAEMT ADVOCACY

Advocating for the EMS workforce and our patients is one of the most important activities NAEMT does each year. NAEMT advocates for laws that enhance the resources, working conditions, pay, safety and training available to EMS practitioners, improves the quality of care for our patients, and ensures EMS is prepared to respond to all types of crises. Through advocacy, NAEMT works to make sure that EMS is included in federal policies, plans and programs.

Thank you to the members of NAEMT's Advocacy Committee for leading our advocacy initiatives, and thank you to NAEMT's advocacy coordinators, who work to increase awareness of NAEMT advocacy initiatives in their state. These dedicated NAEMT members volunteer their time to educate and inform elected officials, their EMS colleagues, the public and other stakeholders about the vital role of EMS in the community, and build support for legislation that benefits our profession and the patients we serve. NAEMT joined with other EMS, fire, physician and safety organizations to accomplish several legislative victories.

In 2019, NAEMT's Advocacy Committee reviewed 34 bills that, if enacted, will affect the EMS workforce and our patients. The committee then recommends the NAEMT Board either support or oppose the measures. The positions taken can be found on NAEMT's website. CELEBRATING 2019'S ADVOCACY VICTORIES

SUPPORTING AND IMPROVING RURAL EMS NEEDS (SIREN) ACT FUNDING

NAEMT secured \$5 million in funding for the SIREN Act, starting in 2020. The grant program will support public and nonprofit EMS agencies in rural areas to train and recruit staff, provide education to satisfy certification requirements, and purchase critical supplies and equipment, such as PPE, naloxone, first aid kits, power stretchers and new ambulances.

VOLUNTEER RESPONDER INCENTIVE PROTECTION ACT (VRIPA)

VRIPA allows volunteer EMS and fire personnel to receive incentives, free of federal income tax, to boost recruitment and retention at volunteer agencies. Incentives may include property tax deductions and up to \$600 per year of other types of benefits, such as clothing, stipends or retirement contributions.

PANDEMIC AND ALL-HAZARDS PREPAREDNESS AND ADVANCING INNOVATION ACT (PAHPA)

This legislation improves the nation's preparation and response to public health threats, whether natural or man-made. The bill included several NAEMT legislative priorities, including:

- Mission Zero Act, authorizing the Assistant Secretary for Preparedness and Response (ASPR) to award grants to enable military trauma surgeons to provide trauma care at civilian trauma centers. The grants help maintain military surgical battle readiness while improving civilian access to trauma care.
- The Good Samaritan Act, which protects healthcare professionals, including EMS practitioners, from liability when serving as a volunteer during disaster response.
- Authorization for the Regional Health Care Emergency Preparedness and Response System, to create regional systems of trauma centers, hospitals, and other public and private entities.
- Increased funding for the Hospital Preparedness Program, which supports regional collaboration through the development of healthcare coalitions.

NAEMT PARTNERS WITH U.S. NAVY ON MILITARY TRANSITION SURVEY

NAEMT's Military Relations Committee partnered with the U.S. Navy to conduct a survey of military medics, both veterans and active duty, to identify barriers to achieving civilian EMS certification and transitioning into civilian EMS jobs. Researchers from the Naval Medical Center in San Diego presented the results at the NAEMSP Annual Meeting.

10TH ANNUAL EMS ON THE HILL DAY

EMS professionals from around the nation gathered in Washington, D.C., on April 10 for EMS On The Hill Day. In meetings with members of Congress and their staff, EMS professionals helped members of Congress understand the vital role of EMS in the community, as well as advocated for specific legislation, including SIREN funding, the Volunteer Responder Incentive Act (VRIPA), the Workplace Violence Prevention for Health Care and Social Service Workers Act, and the Helping Emergency Responders Overcome (HERO) Act.

NAEMT first hosted EMS On The Hill Day in 2010 to bring together a diverse cross section of the nation's EMS community to speak with a unified voice to our nation's top lawmakers. We were proud to celebrate the 10th annual event in 2019, and look forward to bringing together EMS practitioners on Capitol Hill to advocate for our profession in the future!



EMS LEGISLATOR OF THE YEAR AWARD

Sen. Dick Durbin (D-IL) was named the 2019 NAEMT EMS Legislator of the Year. Durbin introduced the SIREN Act in the Senate and is a long-time champion of high quality prehospital care.

NEW BIPARTISAN TEAM LEADS CONGRESSIONAL EMS CAUCUS

POSITIONS, LETTERS AND COMMENTS

NAEMT publishes statements, letters and comments to communicate our positions to lawmakers and federal agencies on proposed legislation and policies. In 2019, NAEMT provided comments on many important issues. Here is a selection:

POSITION STATEMENTS

EQUITABLE PAY AND BENEFITS FOR EMS

In an editorial, the *New York Times* called for New York City EMTs and paramedics to receive pay and benefits that are more on par with FDNY firefighters.

NAEMT supported the opinion of the *Times'* editorial board. In December, the NAEMT Board of Directors issued a position statement affirming that EMS practitioners' pay should be comparable to their partners in public safety and allied health occupations.

"NAEMT is committed to advocating on behalf of EMS practitioners to ensure they receive equitable compensation that reflects the value of their service to their patients, communities, states and nation."



ACCURATE COUNTING OF THE EMS WORKFORCE

The U.S. Department of Labor's Bureau of Labor Statistics (BLS) tracks the number of people employed in various job classifications. Currently, the BLS groups EMTs and paramedics into the same

occupational classification. Volunteer EMTs and paramedics are not counted, while firefighter-EMTs and firefighter-paramedics are most likely classified solely as firefighters rather than their dual role as EMS practitioners.

All of this has led to a significant undercounting of the number of people in the EMS workforce, according to the NAEMT position statement. An accurate count is needed to ensure the U.S. is training and hiring enough EMTs and paramedics to meet the nation's needs. "The lack of an accurate count of the current U.S. EMS workforce creates a potential gap in our national security, as expectations for emergency medical response to public health emergencies

and natural or manmade disasters that are national or regional in scope are based on a belief in the EMS system's ability to respond rather than data supporting its capacity to actually do so."

ENHANCED EDUCATION REQUIREMENTS

In 2019, a debate heated up about whether paramedics should be required to have associate degrees. The NAEMT Board of Directors published a statement in response, noting that "NAEMT believes in enhanced educational requirements for the EMS workforce that support the evolving role of EMS," and encourages EMS practitioners to seek out additional education opportunities. NAEMT called for all national EMS organizations to come together to develop a unified strategy.

LETTERS

EXEMPT GROUND AMBULANCE FROM SURPRISE BILLING LEGISLATION

NAEMT joined with the Congressional Fire Services Institute, the International Association of Fire Chiefs (IAFC), the International Association of Fire Fighters (IAFF) and the National Volunteer Fire Council to urge lawmakers to exempt ground ambulance services from proposed legislation that prohibits balance billing. EMS agencies are already under-reimbursed relative to the cost of providing services for the uninsured and others, and prohibitions on balance billing would put further financial strain on ground ambulance services.



INCLUDE EMS IN NATIONAL HEALTH SECURITY STRATEGY

In a letter to the Office of the Assistant Secretary for Preparedness and Response (ASPR), NAEMT called attention to the omission of EMS from the 2019-2022 National Health Security Strategy. The National Health Security Strategy provides a vision for strengthening the nation's ability to prevent, prepare for, respond to, and recover from disasters and emergencies.

COMMENTS



SEEK INPUT FROM EMS BEFORE REVISING NATIONAL EMS EDUCATION STANDARDS

The National EMS Education Standards are the minimum educational objectives entry-level EMS personnel need to meet. The standards are used by accreditation organizations to evaluate EMS education curriculum. The National Highway Traffic Safety Administration (NHTSA) Office of EMS is working with the National Association of EMS Educators (NAEMSE) to revise the education standards.

NAEMT called for surveying a wide range of EMS agencies to identify areas of strength and weakness, and to determine how well current education programs are preparing the workforce to meet the demands of their job. In addition, NAEMT also provided expert input on ways to improve the proposed revisions.

IMPROVE INTEROPERABILITY OF HEALTH INFORMATION

NAEMT submitted a comment to the Office of the National Coordinator for Health Information Technology (ONC) recommending that ONC continue to develop ways for EMS to share health information with other healthcare providers, and vice versa.

INITIATIVES

HELPING TO REFORM EMS PAYMENT MODELS TO BENEFIT OUR PATIENTS AND PRACTITIONERS

In 2019, NAEMT worked with federal agencies and other national EMS organizations on EMS payment reform – and had some significant successes.

Although changes are underway, EMS continues to be reimbursed primarily as a transportation provider, and is paid a fee-for-service for transporting patients to a hospital emergency department. While these reimbursements are obviously vital to supporting our nation's EMS services, the economic model has led to an undervaluing of the medical care provided by EMS practitioners.

Payment reform is a necessary step in ensuring our nation's EMS agencies have the support needed to fulfill their mission of providing excellent patient care and serving the community during times of crisis. Payment reform will also help ensure that EMS agencies have the resources to provide the compensation and safe working environment that EMS practitioners deserve.

In 2019, EMS payment reform took several important steps forward.

ET3 MODEL ESTABLISHED

NAEMT worked with the Centers for Medicare and Medicaid Services (CMS) and the Center for Medicare & Medicaid Innovation (CMMI) to evaluate alternate EMS roles, such as treat-and-refer services, transport to alternate destinations, community paramedicine and 911 nurse triage.

This work – along with the efforts of those who have worked to advance community paramedicine – culminated with the Feb. 14 announcement of the Emergency Triage, Treat and Transport (ET3) Model. EMS agencies participating

in ET3 will receive payments from CMS for transporting patients to alternate destinations, and for providing treatment in place or via telehealth by a “qualified healthcare practitioner.” Qualified health practitioners include physicians, physician assistants, nurse practitioners and potentially other medical professionals. ET3 is scheduled to launch in 2020.

ET3 WEBINAR OFFERED BY NAEMT, NAEMSP AND IAFC

NAEMT joined with the National Association of EMS Physicians (NAEMSP) and the International Association of Fire Chiefs (IAFC) to present a webinar explaining ET3 opportunities to agencies.

COST COLLECTION BEGINS

As we make progress toward the goal of paying EMS for providing medical care rather than just transportation, NAEMT continued to advocate for higher reimbursement rates by Medicare and Medicaid, especially related to taking care of the uninsured, who place exceptional financial pressure on EMS agencies.

Under the Bipartisan Budget Act of 2018, ground ambulance services had to begin sharing data on costs, utilization and revenue with CMS starting in January 2020. About 25% of ambulance services have been selected to collect cost data in 2020 for a continuous 12-month period, followed by 25% the following year and so on through 2023 until all ambulance services have provided this information.

Cost data will give the EMS community the facts needed to build a strong case for higher reimbursement rates. The aggregate (combined) data will be used to create an ambulance fee schedule that reflects the true costs of providing ambulance services.



CMS's final rule on cost collection was created with input from NAEMT and other stakeholders and published in November 2019. In addition, NAEMT convened a workgroup representing a wide range of EMS provider types (fire-based, hospital-based, private, public utility model and volunteer) from different geographic areas, including urban, suburban and rural. The workgroup offered specific recommendations to CMS to ensure EMS agencies are able to comply with the new CMS rules.

NAEMT has also formed a Cost Collection Task Force to help small EMS agencies, which may not have robust data collection and billing systems in place, prepare to meet the new requirements.

INITIATIVES

SUPPORTING THE EMS TRANSFORMATION

NAEMT continued to help our profession drive progress toward its transformation into a fully integrated component of the healthcare continuum, providing prehospital and out-of-hospital emergent, urgent and preventive care, and reimbursed accordingly. In 2019, NAEMT focused efforts on:

- Raising awareness and educating the EMS community and stakeholders about the ET3 model, which provides new opportunities for EMS to provide alternative services.
- Providing education and support for EMS in developing community paramedicine and mobile integrated healthcare services and programs.
- Providing education to EMS practitioners on the economics of EMS, including the variety of ways in which EMS is financed, how EMS is reimbursed, and how the EMS economic model underpays EMS agencies for the care provided to patients.

SPECIFIC PROJECTS



HOSTING THE 2019 EMS TRANSFORMATION WORKSHOPS

During the 6-hour workshops held in Arlington, Virginia, in conjunction with EMS On The Hill Day, participants had the option of attending a workshop focusing on EMS finances or on clinical requirements for community paramedics.

SURVEY ON NONTRADITIONAL EMS SERVICES

The survey asked EMS agencies about the nontraditional services they were offering, such as community paramedicine, mobile integrated healthcare, transport to alternate destinations, treatment on scene and referral to follow-up care in lieu of transport, and nurse triage. The results were published in early 2020.

HOSTING THE EMS FINANCE WEBINAR SERIES

NAEMT partnered with the Academy of International Mobile Healthcare Integration (AIMHI) on a series of webinars to help EMS practitioners understand EMS finances and how it affects their jobs. The webinars each attracted several hundred participants and are available at naemt.org. Under “Events,” select “EMS Webinars” or access the webinars through Recert for continuing education credit.

In 2019, NAEMT surveyed EMS agencies about the nontraditional services they offer. The survey received 354 responses from all types of EMS delivery models across the United States. These are the results.



INITIATIVES

SUPPORTING EMS HEALTH AND SAFETY

Few things are more important to our association than the health and safety of EMS practitioners. NAEMT is committed to making sure our EMS agencies have the resources they need to ensure the physical and mental well-being of their workforce. 2019's health and safety-related initiatives included:

NATIONAL REPORT ON VIOLENCE AGAINST EMS PRACTITIONERS

With expertise and guidance from NAEMT's EMS Workforce Committee, NAEMT surveyed EMS practitioners about the incidence of violence against EMS practitioners, perceptions of how safe they are on the job, agency policies and procedures to prevent violence, and what EMS practitioners feel should be done to stop violence. The results were published in a national report that was distributed to NAEMT members, federal agencies, members of Congress and other stakeholders.



ADVOCATING FOR LAWS THAT PREVENT VIOLENCE

In 2019, NAEMT advocated for the Workplace Violence Prevention for Health Care and Social Service Workers Act (H.R. 1309), which was passed by the House in November. The bill is intended to curb the epidemic of violence against healthcare and social service workers, including EMS, by requiring employers to develop comprehensive workplace violence prevention plans. In 2020, NAEMT is working toward passing the bill in the Senate.

Another legislative priority was advocating for the Helping Emergency Responders Overcome (HERO) Act, which provides resources to increase recognition and treatment of post-traumatic stress in EMS practitioners and firefighters.

CO-LEADERSHIP OF THE NATIONAL EMS SAFETY COUNCIL

NAEMT also continued to partner with the American College of Emergency Physicians (ACEP) to co-lead the National EMS Safety Council. The council, which includes representatives from 14 national EMS, fire, and safety organizations, promotes a safe and healthy work environment for EMS practitioners and their patients.





The mission of NAEMT education is to improve patient care through high quality, cost effective, evidence-based education that strengthens and enhances the knowledge and skills of EMS practitioners. NAEMT education emphasizes critical thinking skills to obtain the best outcomes for patients.

NAEMT and our teams of experts devote hundreds of hours to developing content and field-testing each course. Existing courses are regularly reviewed and updated, while new courses are developed to meet the evolving needs of EMS practitioners, military personnel and other healthcare and public safety professionals.

STUDENTS TAKING NAEMT COURSES CONTINUES TO RISE



NEW IN 2019

NAEMT published the following revised course materials:

ADVANCED MEDICAL LIFE SUPPORT (AMLS) 3RD EDITION TEXTBOOK

The AMLS 3rd edition textbook features new chapters on mental health emergencies, sepsis and pharmacology. Endorsed by the National Association of EMS Physicians, Advanced Medical Life Support (AMLS) is the gold standard of education for emergency medical assessment and treatment.

TACTICAL EMERGENCY CASUALTY CARE (TECC) 2ND EDITION COURSE MATERIALS

The TECC 2nd edition course manual and instructor toolkit incorporate the latest evidence-based medicine and scenarios that reflect the tactical situations civilian EMS responders are most likely to face.

PREHOSPITAL TRAUMA LIFE SUPPORT (PHTLS) 9TH EDITION MILITARY TEXTBOOK

The military version of the globally recognized 9th edition PHTLS textbook contains 13 chapters written by members of the U.S. Department of Defense Committee on TCCC (CoTCCC) and leading subject matter experts to be used by instructors teaching Tactical Combat Casualty Care (TCCC). The textbook presents the latest research, best practices and lessons on treating traumatic injuries in all environments – from the battlefield to the streets.

PHTLS REFRESHER COURSE MATERIALS AND OPTIONAL LESSONS

In 2019, the PHTLS 9th edition 8-hour Refresher course was published. The course helps EMS practitioners refresh their knowledge and skills to maintain proficiency.

To enable PHTLS instructors to tailor the course to meet local needs, the PHTLS Instructor Toolkit now includes four new optional lessons covering:



- Altitude Emergencies
- Heat-Related Illnesses (Hyperthermia)
- Cold-Related Illnesses (Hypothermia)
- Dive Emergencies

In March, NAEMT held its first international PHTLS instructor update, presented in Spanish in Quito, Ecuador.

BETA TESTING THREE NEW COURSES

NAEMT held beta tests for three new courses – PHTLS for First Responders, Tactical Emergency Casualty Care–Law Enforcement Officers (TECC-LEO), and Critical Care Test Prep (CCTP).

PHTLS for First Responders is an 8-hour classroom course for first responders including emergency medical responders (EMR), firefighters, rescue personnel and law enforcement officers. The course trains first responders to provide the most effective trauma treatment before EMS arrives on the scene.

CCTP will help paramedics successfully take the International Board of Specialty Certifications (IBSC) Flight Paramedic or Critical Care Paramedic Certification and recertification exams.

The TECC-LEO beta test was conducted with the help of the New York Police

Department (NYPD). The course prepares law enforcement officers and other non-EMS first responders to save lives in tactical situations. The beta course was offered to approximately 700 officers in the NYPD Emergency Services Unit.

What is a beta test?

After the authors develop the course materials, NAEMT faculty run the courses with EMS instructors and students. The validation process ensures that course materials are understandable, accessible and meet NAEMT standards for quality. Student and instructor feedback is then incorporated into the final course.

Work underway

NAEMT courses are continually updated to reflect the latest evidence and ensure our courses are relevant, engaging and use the most innovative teaching methodologies. In 2019, we worked on several curriculum development projects, including:

- Emergency Pediatric Care (EPC) 4th edition
- Community Paramedicine Practitioner (new!)
- Review of All Hazards Disaster Response (AHDR), Geriatric Education for EMS (GEMS) and EMS Safety, by teams of subject matter experts in preparation for revision.
- NAEMT Instructor Preparation Course, 2nd edition

RECERT: ONLINE EDUCATION IS NEEDED NOW MORE THAN EVER

Recert (recert.com) offers over 200 online learning modules covering a wide range of topics in EMS, including trauma, stroke, shock, infection control/PPE, pediatrics, safety, psychiatric and behavioral emergencies, pharmacology and special patient populations. Courses are typically 1 to 2 hours and can be used toward meeting recertification requirements. NAEMT partners with the Public Safety Group of Jones & Bartlett Learning on Recert.

TRAUMA EDUCATION



PREHOSPITAL TRAUMA LIFE SUPPORT (PHTLS)

Prehospital Trauma Life Support (PHTLS) is the world's leading continuing education program for prehospital emergency trauma care. The mission of PHTLS is to promote excellence in trauma patient management, improve the quality of trauma care and decrease mortality. PHTLS is developed by NAEMT in cooperation with the American College of Surgeons' Committee on Trauma (ACS-COT). The program emphasizes treating the complex needs of multi-system trauma patients. PHTLS promotes critical thinking as the foundation for providing quality care.



ALL HAZARDS DISASTER RESPONSE (AHDR)

172 Courses
1,801 Students

In its 3rd year, the number of students taking All Hazards Disaster Response (AHDR) continued to grow, both in the U.S. and internationally. AHDR teaches EMS practitioners how to respond to the many types of disaster scenarios, including natural disasters and infrastructure failings, fires and radiological events, pandemics, active shooter incidents, and other mass casualty events. AHDR educates participants on how to analyze potential threats in their area, assess available resources, and create a medical response plan that saves lives.

TACTICAL COMBAT CASUALTY CARE (TCCC)

Tactical Combat Casualty Care (TCCC) was created by the U.S. Department of Defense (DoD) Committee on TCCC (CoTCCC) to teach evidence-based, life-saving techniques and strategies for providing the best trauma care on the battlefield. NAEMT conducts TCCC courses as specified by CoTCCC's guidelines and curriculum. TCCC, as offered by NAEMT, is the only TCCC course endorsed by the DoD Joint Trauma System and the American College of Surgeons.

TACTICAL EMERGENCY CASUALTY CARE (TECC)

Tactical Emergency Casualty Care (TECC) 2nd edition curriculum covers the tactical situations civilian EMS practitioners are most likely to encounter. NAEMT's TECC course meets the guidelines established by the Committee on Tactical Emergency Casualty Care (C-TECC) and the National Tactical Emergency Medical Support Competency Domains (TEMS). Designed to decrease preventable deaths in tactical situations such as terrorist attacks, hostage scenarios and active shooter events, TECC applies lessons learned in battle to mass casualty scenarios in civilian environments.



MEDICAL EDUCATION



ADVANCED MEDICAL LIFE SUPPORT (AMLS)

Advanced Medical Life Support (AMLS) is the gold standard of education for emergency medical assessment and treatment. Endorsed by the National Association of EMS Physicians (NAEMSP), AMLS emphasizes the use of the AMLS Assessment Pathway, a systematic tool for assessing and managing common medical conditions with urgent accuracy. The course emphasizes the use of scene size-up, patient history, interactive group discussion on potential treatment strategies, and physical exam to systematically rule out and consider possibilities and probabilities in treating patients' medical crises.

Students may also take AMLS-Basics, a course introduced in 2018 and tailored to meet the education needs of EMTs.

In October, NAEMT held the 3rd edition AMLS Instructor Update as a preconference workshop at EMS World Expo in New Orleans. The update covered the changes to the AMLS textbook, including new chapters on sepsis, pharmacology and mental health emergencies, along with new patient simulations and other new course features.



EMERGENCY PEDIATRIC CARE (EPC)

442 Courses
4,528 Students

Emergency Pediatric Care (EPC) focuses on critical pediatric physiology, illnesses, injuries and interventions to help EMS practitioners provide the best treatment for sick and injured children in the field. The course stresses critical thinking skills to help practitioners make the best decisions for their young patients. Topics covered include the pathophysiology of the most common critical pediatric emergency and application of the Pediatric Assessment Triangle (PAT), a tool to help EMS practitioners rapidly and accurately assess pediatric patients.

GERIATRIC EDUCATION FOR EMS (GEMS)

482 Courses
3,972 Students

Geriatric Education for EMS (GEMS) provides EMS practitioners at all levels with the skills and knowledge to address the unique medical, social, environmental and communications challenges of older adults. Developed by NAEMT in partnership with the American Geriatrics Society (AGS), GEMS empowers EMS practitioners to help improve medical outcomes and quality of life for geriatric patients. Two GEMS courses – a core and an advanced course – are available. GEMS features case-based lectures, live action video, hands-on skill stations, simulation and small group scenarios to fully engage students in the learning experience.

PSYCHOLOGICAL TRAUMA IN EMS PATIENTS (PTEP)

97 Courses

Psychological Trauma in EMS Patients (PTEP) teaches EMS practitioners to help alleviate patients' hidden wounds – intense fear, stress and pain – during a medical emergency. PTEP educates EMS practitioners about the biological underpinnings of psychological trauma, the short and long-term impact on the brain and body, and warning signs that a patient is experiencing extreme psychological distress. Through scenario-based interactive sessions, EMS practitioners are also taught strategies and techniques to alleviate patients' distress and help patients cope with what they're experiencing to ward off lingering effects.

EMS SAFETY

EMS Safety teaches students how to protect themselves and their patients while on the job. It promotes a culture of safety and helps reduce the number of on-the-job fatalities and injuries. EMS Safety is the only national, comprehensive safety course for EMS practitioners. Its interactive format features real-life case studies and compelling discussions on current safety issues, and provides participants with a forum to share their own experiences. Critical thinking stations help build participants' risk assessment and decision-making skills.



EMS VEHICLE OPERATOR SAFETY (EVOS)

With a focus on creating a culture of safe driving, EMS Vehicle Operator Safety (EVOS) draws on the most current research about specific behaviors and other hazards that lead to crashes. EVOS features case studies and analyses of both common and catastrophic collisions to challenge EMS practitioners to reconsider their preconceptions about safe vehicle operations. Instructors can easily incorporate local laws, rules and policies into the curriculum.

PRINCIPLES OF ETHICS AND PERSONAL LEADERSHIP (PEPL)

Principles of Ethics and Personal Leadership (PEPL) provides EMS and mobile healthcare practitioners with the skills and knowledge to effectively interact with patients and their families, other medical personnel, co-workers, supervisors and the community at large. Through course presentations, dialogue, and learning activities, including written and video case studies, students explore the importance of ethics and personal leadership, identify their leadership roles in civic life as individuals, family members, professionals and members of the community, and practice the skills important to the exercise of personal, ethical leadership.

NAEMT INSTRUCTOR PREPARATION COURSE

The NAEMT Instructor Preparation Course is a prerequisite for any EMS instructor who wishes to teach NAEMT courses. In 2019, 4,568 instructor candidates took the course, which is offered online in English and Spanish, and as a classroom course in multiple other languages.






NAEMT ANNUAL MEETING & EVENTS

CELEBRATING EMS WEEK

NAEMT partnered with the American College of Emergency Physicians (ACEP) on the EMS Strong Campaign, which encourages the celebration of EMS Week, held May 19 to 25. 2019's theme was "Beyond the Call."



SEPSIS AWARENESS CAMPAIGN

NAEMT joined with the Sepsis Alliance to raise awareness about this life-threatening condition. On behalf of the Sepsis Alliance, NAEMT conducted a pediatric sepsis awareness survey, created an educational resource library on our website, and offered a sepsis learning module on Recert.



GET AHEAD OF STROKE WEBINAR

NAEMT hosted a Get Ahead of Stroke webinar in April to share best practices on identifying stroke in the prehospital environment. The webinar was presented in partnership with the Society of NeuroInterventional Surgery, with a grant from the Medtronic Foundation. Dr. Craig Manifold, NAEMT medical director, also participated in a #StrokeCareChat on Twitter, hosted by the Get Ahead of Stroke Campaign.

PREHOSPITAL TXA USE SURVEY

NAEMT assisted the Warren Alpert Medical School of Brown University and the Department of Emergency Medicine at Rhode Island Hospital with a survey of EMS providers about the prevalence of EMS protocols for tranexamic acid (TXA) use to treat hemorrhage.

AMBULANCE TODAY

NAEMT provides an article for each issue of *Ambulance Today*, a quarterly magazine for EMS practitioners published in the United Kingdom.

ASSISTING THE SOCIETY FOR AIRWAY MANAGEMENT
