## Our Mission, Values and Vision

The mission of the National Association of Emergency Medical Technicians (NAEMT) is to represent and serve emergency medical technicians (EMTs), advanced EMTs, paramedics, and specialty paramedics, and support personnel through advocacy, education, and research.

#### **OUR VALUES**

We believe that:

- EMS is a distinct and essential service to the public and a fundamental component of our nation's healthcare and emergency response systems. Local, state, and federal government authorities as well as commercial insurers must share the responsibility for adequately funding EMS.
- EMS is uniquely positioned to support our nation's healthcare and emergency response systems by providing high quality emergent, urgent, and preventive patient care delivered by qualified EMS practitioners trained to assess, treat, and navigate patients to the right care, in the right place, at the right time.
- All communities have the right to determine the EMS delivery model(s) that best meets their needs and resources.
- The EMS workforce deserve a safe, healthy, and respectful work environment, and should receive appropriate compensation for the lifesaving healthcare they provide to their patients and their critical role in responding to disasters, public health crises, and mass casualty incidents.
- The EMS workforce should reflect the demographics of the communities in which it serves. National and state EMS associations have a responsibility to promote diversity, equity and inclusion within the EMS profession.
- The EMS industry has a responsibility to develop future industry leaders through professional development and mentorship opportunities.
- Collaboration within the EMS industry and within the larger healthcare community is essential to addressing the key challenges in delivering high-quality EMS.
- The provision of EMS should be based on the latest evidence and best practices.
- EMS must be supported by education and certification systems that produce welltrained, resilient professionals qualified to provide the patient care demanded of their positions.

 Emergency medical technicians (EMTs), advanced EMTs, paramedics, and specialty paramedics should be represented by a professional association committed to advancing their profession, representing their professional interests and serving their professional and educational needs, irrespective of the workplace setting they choose to use their education, training and certification.

We shall conduct all NAEMT business with integrity and transparency, and adhere to the ethical standards of our profession.

#### **OUR VISION**

NAEMT will focus its efforts and resources in support of these values by actively:

- Advocating for appropriate funding for all EMS agencies and personnel from all delivery models and workplace settings.
- Educating government and healthcare leaders on the value of EMS to our nation's healthcare and emergency response systems.
- Advocating for and supporting the health, safety, well-being and resilience of the EMS workforce.
- Promoting diversity, equity and inclusion within the EMS workforce and encouraging and supporting EMS recruitment from underrepresented communities.
- Advocating for education and certification systems that support well-trained and qualified EMTs, Advanced EMTs and paramedics.
- Developing and disseminating high quality, evidence-based education that strengthens and enhances the knowledge, skills, and resilience of the EMS workforce, and EMTs, advanced EMTs, paramedics and specialty paramedics working in other settings.
- Providing professional development and mentorship opportunities to EMS personnel interested in serving in EMS leadership positions.
- Communicating the professional opportunities and career pathways available to certified or licensed emergency medical technicians (EMTs), advanced EMTs, paramedics, and specialty paramedics.



## From the President

# 2022 dawned with a sense of both optimism and uncertainty in EMS.

The performance of EMS during the pandemic had helped bring far greater awareness within our communities and the healthcare system of the role that EMS plays in population health. We expanded the services provided, including administration of vaccinations and antibodies, transport to destinations other than the emergency department, telehealth facilitation, and treatment in place. In 2022, one of our key advocacy goals was building on this greater awareness of what EMS can do to secure additional federal support for EMS and for certain pandemic provisions to be made permanent.

Even as there were reasons for optimism, the challenges faced by EMS were painfully obvious. We faced an exponential increase in workforce stress and illness, compounded by a shortage of personnel never before experienced. To support EMS in facing these challenges, NAEMT led several initiatives focused on addressing workforce recruiting and retention difficulties, protecting the mental health and safety of EMS practitioners, and building resilience within our agencies.

- Launching the Lighthouse Leadership Program to mentor a new generation of EMS leaders, helping them to nurture their careers and ideally stay in EMS for the long-term.
- Publishing the results of our national survey of EMS practitioners on workforce engagement and satisfaction, to help EMS agencies and other stakeholders better understand EMS practitioner perspectives on their work, and what they need from their employers to flourish in their careers.
- Publishing the new Mental Health Resilience Officer (MHRO) course and the EMS Safety 3rd edition to provide education and training that protects the mental health and safety of crews.
- Continuing our popular webinar series, on topics ranging from preparing for grant opportunities to safely caring for agitated patients to the use of lights and sirens.
- Advocating in Congress for legislation that reforms reimbursement and provides funding to EMS agencies to ensure our workforce is well equipped, well trained and prepared for all of the challenges faced in the field.
- Reaching out to central and eastern European countries to provide them with much-needed prehospital training, and to support medical first responders in Ukraine.

#### A HEART OF SERVICE

Day and night, across big cities and small rural communities in the United States and across the world, people trust EMS professionals to help them when they most need it.

Overcoming challenges, and perseverance, are defining traits of our profession and workforce. The tremendous contributions of EMS practitioners to the health and safety of our communities must always be acknowledged and appreciated. The dedication of our nation's EMS professionals also drives the work of NAEMT.





## Translating Simulations Into Better Outcomes - Yours and Theirs!

Megan Corry and Dave Page used NAEMT AMLS patient simulations for a deep dive into using simulations to improve learning and patient care.

## How to Prepare for EMS Grant Opportunities

Beth Bowsky of Public Consulting Group (PCG) explored how EMS agencies can prepare for grant opportunities, including finding grants, collecting data, meeting grant requirements and submitting successful grant applications.

#### Managing Patients with Agitated Behavior

Dr. Christopher Colwell shared best practices on managing agitated patients in the prehospital setting, including when to use physical and pharmaceutical restraints.

## Establishing a Prehospital Whole Blood Program

Dr. C.J. Winckler and William Bullock of the San Antonio Fire Department discussed their prehospital whole blood resuscitation program, including logistics, training requirements, and lessons learned.

#### Defining the Standard of Care in Prehospital Airway Management

Dr. Henry Wang and Dr. Jeff Jarvis discussed the National Association of EMS Physicians (NAEMSP) prehospital airway management compendium.



### Educator Sim Series: Effective Debriefing – Engaging Your Students

Dave Page shared strategies for effective patient simulation debriefs to help students achieve deep learning and improve future performance.

#### What's Your Ambulance Service "Worth?"

Tim Nowak of PCG provided strategies to identify expense allocations and how they compare to others within the industry, and discussed communication strategies to better inform stakeholders and the public of your agency's finances, challenges and plans.

#### Strategies for Creating a Culture of Engagement in EMS

Robert Luckritz moderated a panel of EMS managers from a variety of EMS delivery models on cost-effective strategies to engage their workforce, increase recruitment and retention, and minimize turnover costs.

## EMS Lighthouse Leadership Program .

NAEMT launched the EMS Lighthouse Leadership Program in 2022 in response to member feedback expressing a desire for mentors to help with career and professional development. The program matches selected NAEMT members with experienced EMS leaders, who assist with creating a plan for professional development, a strategy for achieving goals, and providing guidance in getting there.





The mentorship program runs 18 months, and includes an orientation, one-on-one mentoring, group mentoring opportunities via Zoom and an in-person networking event.

The EMS Lighthouse Leadership Program was spearheaded by Bruce Evans (NAEMT President 2021-2022), who was inspired by the late James O. Page. Page, a longtime Los Angeles fire chief known for helping to shape modern-day EMS, had envisioned starting an EMS mentorship program for EMS prior to his death.

## Advocacy

Advocating on behalf of the EMS workforce is core to NAEMT's mission. NAEMT advocates for laws that help ensure EMS practitioners have the training, equipment, and support needed to provide excellence in patient care and maintain their mental and physical well-being.

Through advocacy, NAEMT also works to make sure that EMS is involved in the development of federal policies, plans and programs that impact our workforce and our communities.

NAEMT uses numerous strategies to advance our advocacy initiatives:

- Hosting events such as EMS On The Hill Day that invite EMS practitioners to Washington, D.C., to speak directly with members of Congress.
- Promoting digital outreach campaigns using our Online Legislative Service so that elected officials at the state and federal levels hear directly from their EMS constituents.
- Publishing surveys, research and reports on urgent issues in prehospital care that we share with Congress, government agencies, and the wider stakeholder community to raise awareness and build support for key initiatives.



- Participating in national forums on trauma care, disaster planning and public health to ensure the EMS perspective is included.
- Working with NAEMT's professional lobbyists, who are on Capitol Hill working on behalf of our profession and our patients.
- Making campaign contributions to candidates for federal elective office through the NAEMT EMS PAC to help elect or re-elect federal candidates who are friends of our profession.

Another vital component of our advocacy strategy: collaborating with other national EMS, fire, physician and healthcare organizations. By building consensus among stakeholders and working together to build support in Congress for legislative initiatives, we are able to accomplish more.

Thank you to the members of NAEMT's Advocacy Committee for helping to lead our association's advocacy initiatives. Their work includes reviewing bills and recommending to the NAEMT Board about whether to support the legislation; preparing position statements, letters and comments to Congressional committees on proposed legislation or regulatory initiatives; and developing strategies to increase participation in grassroots EMS advocacy.

Thank you also to NAEMT's advocacy coordinators, who work to increase awareness of NAEMT advocacy initiatives in their state. These dedicated NAEMT members volunteer their time to educate and inform elected officials, their EMS colleagues, the public and other stakeholders about the vital role of EMS, and build support for legislation that benefits our profession and the patients we serve.

Digital Outreach 9,000 Emails to elected officials sent using NAEMT's Online Legislative Service in 2022 It's always great to celebrate a win! The passage of the fiscal year 2023 Omnibus Bill in December 2022 brought several advocacy victories:

- \$10.5 million for the SIREN grant program, a \$3 million increase from the prior year.
- A 2-year extension of Medicare addon payments for ground ambulance services. The urban 2%, rural 3%, and super-rural 22.6% add-ons that were set to expire on December 31, 2022, will now continue through Dec. 31, 2024.
- Report language that encourages
   Health and Human Services
   Asst. Secretary for Preparedness
   and Response to expand the
   Hospital Preparedness Program
   to include an EMS Preparedness
   and Response Workforce Shortage
   Program.
- A delay of implementation of the 4% pay-go cut that was scheduled to take effect at the end of 2022 until 2025.
- Extension of the delay of the 2% sequestration cuts.

The NAEMT EMS Political Action Committee (PAC) received \$8,765 in voluntary contributions in 2022, bringing the total to \$57,303 at year end.

The NAEMT EMS PAC strengthens our advocacy through support for elected representatives who share the goals of the EMS community. Pooling individual contributions into a PAC fund gives a united voice to thousands of paramedics and EMTs across the nation, creating a stronger impact than individual political contributions. Support for the NAEMT EMS PAC strengthens our collective ability to create changes such as the expansion of grant programs, increased Medicare reimbursement, and payment for mobile integrated healthcare and community paramedicine. Contributions are voluntary, and may be accepted from any U.S. citizen.



## EMS On The Hill Day

### Virtual Event Set New Participation Record

2022's Virtual EMS On The Hill Day set a new record for participation. From April 4 to 8, 312 Hill Day participants met with 241 congressional offices to discuss urgent topics affecting our profession.

With 49 states plus Washington, D.C., and Puerto Rico represented, EMS advocates came together to speak with a unified voice on behalf of EMS and our patients. Specific requests included increased funding for SIREN grants to assist rural EMS, support for EMS workforce development, protecting the Medicare extenders and passing the EMS Counts Act.

### NAEMT National Advocacy Awards

NAEMT's Advocate of the Year awards recognize EMS practitioners who excel in grassroots advocacy that advances the EMS profession and inspire others to take action. 2022's recipients were: David Blevins of Tennessee, Paul Roman of New Jersey and Brian Webb of Alaska.

NAEMT's Legislator of the Year awards recognizes members of Congress for their leadership as champions of EMS. 2022's recipients were: Rep. Susan Wild (D-PA) and Sen. Bob Casey (D-PA) and for their leadership in introducing the EMS Counts Act in the House and Senate.

## First-Ever NAEMT Political Academy


To encourage more EMS practitioners to get involved with politics at all levels, NAEMT held the first-ever EMS Political Academy in December. During the webinar, participants heard from seasoned political experts on how to develop messaging strategies, run campaigns and win local and state elections. Presenters included: Jim Hobart of Public Opinion Strategies, John Oceguera and Matt Davidson of Strategies 360, Oregon State Rep. Dacia Grayber, and New Hampshire State Sen. Sue Prentiss.

## Advocacy



## REPORT: NATIONAL SURVEY OF EMS UTILIZATION OF CMS WAIVERS

In March 2022, NAEMT conducted a survey on how ambulance services were using the waivers issued by the U.S. Centers for Medicare & Medicaid (CMS) during the COVID-19 public health emergency. The waivers allowed ambulance services to be reimbursed for alternative transports, for treatment instead of transport, for facilitation of telehealth, and hospital at home using community paramedics. The survey received over 500 responses from 48 states. The results were provided to Congress to illustrate why it is long overdue to reimburse EMS based on the care delivered, instead of solely for transportation. Changing the EMS reimbursement model will enable EMS agencies to implement transformative care delivery models and reduce preventable emergency department visits.



## VACCINE TOOLKIT FOR EMS COMMUNITY VACCINATION CAMPAIGNS

During the COVID-19 pandemic, EMS agencies stepped up to lead vaccine campaigns to immunize members of underserved or hard-to-reach communities. In July, NAEMT published a new vaccine toolkit that EMS agencies can use to plan and organize community vaccine drives. The toolkit, "EMS: A Valuable Resource for Community Vaccination Campaigns," can be shared with local public health officials or community organizations to help them understand how EMS can support vaccination efforts. The guide explains why EMS is an ideal resource for community vaccine initiatives, along with case studies on EMS agencies that have run successful immunization campaigns. The toolkit also includes a checklist for getting started, and training resources for vaccinators.



## PARTICIPATION IN NATIONAL ACADEMIES FORUMS

NAEMT participates as a member organization on expert forums of the National Academies of Science, Engineering, and Medicine, to provide EMS expertise on issues such as emergency medical care, disaster response, and public health. In 2022, NAEMT leadership participated in the Forum on Medical and Public Health Preparedness for Disasters and Emergencies and the Forum on Traumatic Brain Injury.

## Positions, Letters and Comments

Through position statements, letters to Congressional committees and comments on pending legislation or rules, NAEMT shared the EMS perspective on other urgent issues impacting our profession, our patients and our communities.

#### **POSITION STATEMENTS**

## Requiring Civilian EMS Certification for Military Medics

NAEMT called on the U.S. Department of Defense to implement a program to ensure that all military medics, corpsmen, special operations medical providers and military EMS/fire service providers maintain civilian certification through the National Registry of EMTs (NREMT). Requiring civilian certifications for all U.S. military prehospital providers would strengthen the nation's capacity to respond to disasters.

## Support for Accreditation of Paramedic Education Programs

NAEMT reaffirmed support for requiring accreditation of paramedic education programs. Accreditation assesses the quality of institutions and their programs and services by measuring them against agreed-upon standards. This verifies that institutions are preparing competent entry-level paramedics.

#### Limiting the Use of Lights and Sirens

NAEMT joined 14 national and international EMS and fire associations on a position statement calling for limiting the use of lights and sirens to situations in which the time saved is anticipated to be clinically important. The statement also recommends using emergency medical dispatch (EMD) programs to triage and categorize the urgency of calls, and for robust physician oversight and quality assurance of those programs.

#### **LETTERS**

NAEMT submitted a letter of support to the National Institute for Occupational Safety & Health (NIOSH) on its proposal to establish a "center of excellence" to research and develop new approaches to PPE.

NAEMT requested that House leaders reauthorize the First Responder Network Authority (FirstNet).

NAEMT asked House and Senate leaders for an additional \$25 billion in funds for the Provider Relief Fund, which has helped offset the loss of reimbursement and increased costs of pandemic response.

NAEMT requested that the U.S. Department of Health and Human Services distribute \$350 million leftover from the Provider Relief Fund to fund ground ambulance services.

Along with 14 other national EMS, fire, emergency medicine and mental health organizations, NAEMT asked Congress to enact the bipartisan Post-Disaster Mental Health Act. The legislation expands mental health support for the survivors of natural disasters or terrorist attacks following emergency declarations.

NAEMT asked Congressional leaders to provide \$28 million to fund the Emergency Medical Services for Children (EMSC) program, which is dedicated to improving emergency and trauma care for children, and increasing mental health capacity for children in emergency departments.

In several joint letters from NAEMT and other national EMS and fire organizations to Congressional leadership, NAEMT requested a postponement of impending cuts to Medicare reimbursement triggered by sequestration. Sequestration cuts are automatic federal spending cuts required by statute.

In a letter to Transportation Secretary Pete Buttigieg, NAEMT asked for the Department of Transportation to work with chassis manufacturers to ensure a steady and predictable supply of chassis. The lead time for delivery of new ambulances has increased dramatically since 2020.

In a request to House and Senate leadership, NAEMT and a coalition of national fire and EMS organizations asked that Congress extend and boost the Medicare add-on payments for ground ambulance services to reflect cost increases. The coalition asked that the Medicare add-ons be raised from 2% to 3.4% for ambulance services provided in urban areas, 3% to 4.3% in rural areas, and 22.6% to 26.7% in super rural areas for the next five years.

#### COMMENTS

NAEMT submitted comments to the Office of the Assistant Secretary for Preparedness and Response (ASPR) on the National Health Security Strategy for 2023-2026. The strategy outlines a framework for strengthening the national disaster and emergency response capacity. NAEMT reminded ASPR that EMS must be included in national health security planning.

NAEMT submitted a statement from NAEMT President Bruce Evans to the Senate Subcommittee on Employment and Workplace Safety recommending actions Congress could take to alleviate EMS workforce shortages.

In comments on the National Highway Traffic Safety Administration's National Roadway Safety Strategy, NAEMT recommended whole blood delivery systems administered by paramedics, replacing gas-powered hydraulic extrication equipment with battery-powered equipment, and other recommendations improve post-crash safety and patient care.

NAEMT submitted a comment to the National Registry of Emergency Medical Technicians (NREMT) opposing a proposed policy permitting states to approve paramedic programs, absent accreditation.

In a comment to the Commission on Accreditation of Ambulance Services (CAAS) Standards Committee, NAEMT provided input on proposed revisions to minimum staffing standards, addressing implicit bias and response times.

### INITIATIVE

## Supporting Workforce Recruitment and Retention

Labor shortages reached crises levels at EMS agencies of all types in 2022. Shortages of paramedics and EMTs led some EMS agencies to cut services, and a few to even shut down altogether. The lack of personnel put more pressure on paramedics and EMTs still on the job, who worked longer hours to fill the open positions.

In addition to asking Congress to fund workforce development, NAEMT undertook several projects to raise awareness and offer up potential solutions to address EMS workforce shortages. These initiatives provided EMS agencies with actionable ideas to tackle the issue at the state and local level.



## INNOVATIVE RECRUITMENT STRATEGIES FOR EMS AGENCIES

To assist EMS agencies in attracting new candidates, NAEMT published "Innovative Recruitment Strategies for EMS Agencies." The downloadable guide presented effective recruitment strategies and practices currently in use by EMS agencies. EMS agencies can use or adapt these strategies to their own needs and geographic area. The guide included tips for starting a recruiting program, case studies on successful recruiting campaigns, advice on getting the word out about job openings, and marketing your EMS agency on social media.



## NATIONAL SURVEY ON EMS WORKFORCE SATISFACTION AND ENGAGEMENT

In 2022, NAEMT conducted a national survey asking our members and other EMS practitioners about various aspects of their jobs, including pay, how well supported they feel by employers, and if they had plans to leave the profession. In nearly 1,300 responses, EMS practitioners painted a picture of a workforce that was dedicated to caring for patients and serving the community, but was also exhausted and under a high degree of strain. In insightful comments, hundreds of EMS practitioners shared their ideas for how EMS agencies could improve engagement and satisfaction.



## WEBINAR ON "STRATEGIES FOR CREATING A CULTURE OF WORKFORCE ENGAGEMENT IN EMS"

As a follow up to that report, Rob Luckritz, EMS chief for Austin-Travis County EMS, hosted a webinar on creating a culture of workforce engagement in EMS agencies. The webinar identified cost-effective strategies to engage the EMS workforce, and explored the operational and financial benefits of improving workforce engagement.

## Partnerships

Through our commitment to collaboration with other national organizations, NAEMT helps build a broad base of support for initiatives that benefit EMS practitioners and patients.

#### **NATIONAL EMS WEEK**

NAEMT partners with the American College of Emergency Physicians (ACEP) on the nationwide recognition of EMS Week, held in 2022 on May 15-21, to celebrate and thank our nation's EMS professionals. 2022's theme was "EMS: Rising to the Challenge."



## GUIDANCE DOCUMENT ON MINIMUM STAFFING STANDARDS

NAEMT is leading a joint initiative with the American Ambulance Association (AAA), International Association of Fire Fighters (IAFF), International Association of Fire Chiefs (IAFC), National Association of EMS Physicians (NAEMSP), National Registry of EMTs (NREMT), National Association of State EMS Officials (NASEMSO) and International Academies of Emergency Dispatch (IAED) to begin development of a national guidance document on minimum staffing of EMS personnel for different types of 911 medical calls and scheduled interfacility transports. When completed, this guidance document can be used by state EMS offices, EMS agency leaders, EMS

medical directors and local community leaders when considering revisions to their EMS response plans to determine the optimal staffing configurations that support quality patient care, efficient operations, and practitioner safety.

## SURVEY ON EMS TRAINING TO TREAT PREGNANT AND POSTPARTUM WOMEN

NAEMT partnered with the American College of Obstetricians and Gynecologists (ACOG) to conduct a survey on EMS training to treat emergencies in pregnant and postpartum women. The survey garnered over 1,700 responses and identified areas where EMS practitioners felt they needed more education and training.

## JOINT STATEMENT ON LIGHTS AND SIRENS

NAEMT was one of 14 national and international associations that came together to release a joint statement on the use of lights and sirens during EMS responses. The statement called for limiting the use of lights and sirens to certain time-sensitive clinical situations to reduce the risks of crashes that injure EMS practitioners and the public.



## Supporting the work of other organizations

NAEMT supported the work of several organizations through financial contributions and by raising awareness through articles and emails to our members. In 2022, we provided support to the Prehospital Care Research Forum (PCRF), National EMS Museum and National EMS Memorial Foundation. NAEMT also provided support and sent the members of the NAEMT Board to attend the National EMS Memorial Service and Weekend of Honor, held in Arlington, Virginia.



The NAEMT Foundation is a 501(c)3 nonprofit organization that works to strengthen and build the future of EMS. In 2022, the foundation supported the Health Occupations Student Association International Leadership Conference, and awarded eight scholarships to individuals interested in pursuing a career in EMS.





Officer. MHROs engage with their peers
to understand issues related to mental
health and resilience; identify peers
who are experiencing mental health
stressors and crises; navigate peers to
the right services for help; and support
the development of a culture of mental
health resilience and emotional wellness
within their agency. MHRO can be taught
online, or as a classroom course.





#### **EMS SAFETY 3RD EDITION**

NAEMT published the EMS Safety 3rd Edition, which teaches students how to protect themselves and their patients while on the job. EMS Safety helps reduce the number of on-the-job fatalities and injuries by promoting a culture of safety within EMS agencies. As the only national, comprehensive safety course for EMS practitioners. EMS Safety has an interactive format that features reallife case studies and group discussions on current safety issues, during which students are encouraged to share their experiences. The course was developed by a multidisciplinary group of experts in EMS, education and emergency medicine.

## PREHOSPITAL TRAUMA LIFE SUPPORT (PHTLS) 10TH EDITION

NAEMT's Prehospital Trauma Life Support (PHTLS) is recognized as the EMS profession's premier continuing education program for prehospital emergency care. Developed by NAEMT in cooperation with the American College of Surgeons' Committee on Trauma (ACS-COT), PHTLS teaches EMS practitioners to master critical techniques for saving the lives of multisystem trauma patients. The new, 10<sup>th</sup> edition PHTLS textbook was created by leading subject matter experts and includes vital updates on scene management, patient assessment, airway and ventilation best practices, head and neck trauma/TBI, spinal trauma, and abdominal trauma, among other topics. It was published in English in October 2022.

## NEW COMMUNITY PARAMEDICINE SERIES COURSES

Two additional courses were added to the Community Paramedicine Series in 2022, bringing the total to five:


- THAM EDICINETY OF THE PARTY OF
- Endocrine Disorders is a 3.5-hour course that teaches community paramedics to assist patients diagnosed with endocrine disorders such as diabetes.
- Cardiovascular Disorders is a 3.5hour course that teaches community paramedics to assist patients diagnosed with cardiovascular disorders, such as acute coronary syndrome, coronary artery disease, heart failure, and hypertension.





## EMERGENCY PEDIATRIC CARE (EPC) 4™ EDITION HYBRID COURSE ONLINE COMPONENT

## NAEMT REGIONAL EUROPEAN EDUCATION COMMITTEE MEETING IN VIENNA

In December, NAEMT faculty leaders representing more than 25 European countries met in Vienna to discuss how to grow and strengthen NAEMT education across the continent. The meeting included presentations from regional prehospital experts and panel discussions on differences in trauma guidelines throughout the region, treating illness and injury in refugee populations, and providing appropriate prehospital trauma training to different student populations.

## Trauma Education



## PREHOSPITAL TRAUMA LIFE SUPPORT (PHTLS)

Courses: 6,584 / Students: 65,681

Prehospital Trauma Life Support (PHTLS) is the world's leading continuing education program for prehospital emergency trauma care. The mission of PHTLS is to promote excellence in trauma patient management, improve the quality of trauma care and decrease mortality. PHTLS is developed by NAEMT in cooperation with the American College of Surgeons' Committee on Trauma (ACS-COT). The program emphasizes treating the complex needs of multi-system trauma patients. PHTLS promotes critical thinking as the foundation for providing quality care. NAEMT also offers a PHTLS Refresher course and PHTLS for First Responders.

## ALL HAZARDS DISASTER RESPONSE (AHDR)

Courses: 218 / Students: 2,155

All Hazards Disaster Response (AHDR) teaches EMS practitioners how to respond to the many types of disaster scenarios, including natural disasters and infrastructure failings, fires and radiological events, pandemics, active shooter incidents, and other mass casualty events. AHDR educates participants on how to analyze potential threats in their area, assess available resources, and create a medical response plan that saves lives.

## TACTICAL COMBAT CASUALTY CARE (TCCC)

Courses: 1,613 / Students: 18,472

Tactical Combat Casualty Care (TCCC) is created by the U.S. Department of Defense (DoD) Defense Health Agency's Joint Trauma System (DHA-JTS) based on the TCCC guidelines developed by the Committee on TCCC (CoTCCC) to teach evidence-based, life-saving techniques and strategies for providing the best trauma care on the battlefield. NAEMT conducts TCCC courses as specified by the TCCC guidelines and curriculum. TCCC, as offered by NAEMT, is the only TCCC course endorsed by the American College of Surgeons.

## TACTICAL EMERGENCY CASUALTY CARE (TECC)

Courses: 1,194 / Students: 13,190

Tactical Emergency Casualty Care (TECC) covers the tactical situations civilian EMS practitioners are most likely to encounter. NAEMT's TECC course meets the guidelines established by the Committee on Tactical Emergency Casualty Care (C-TECC) and the National Tactical Emergency Medical Support Competency Domains (TEMS). Designed to decrease preventable deaths in tactical situations, such as terrorist attacks, hostage scenarios and active shooter events, TECC applies lessons learned in battle to mass casualty scenarios in civilian environments. NAEMT also offers a TECC Refresher and TECC for Law Enforcement Officers (TECC-LEO), tailored to non-EMS police and other first responders.









## Medical Education



#### **ADVANCED MEDICAL LIFE SUPPORT** (AMLS)

Courses: 1,828 / Students: 18,310

Advanced Medical Life Support (AMLS) is the gold standard of education for emergency medical assessment and treatment. Endorsed by the National Association of EMS Physicians (NAEMSP), AMLS emphasizes the use of the AMLS Assessment Pathway, a systematic tool for assessing and managing common medical conditions with urgent accuracy. The course emphasizes the use of scene size-up, patient history, interactive group discussion on potential treatment strategies, and physical exam to systematically rule out and consider possibilities and probabilities in treating medical crises.

#### **EMERGENCY PEDIATRIC CARE (EPC)**

Courses: 607 / Students: 7,051

Emergency Pediatric Care (EPC) focuses on critical pediatric physiology, illnesses, injuries and interventions to help EMS practitioners provide the best treatment for sick and injured children in the field. The course stresses critical thinking skills to help practitioners make the best decisions for their young patients. Topics covered include the pathophysiology of the most common critical pediatric emergencies and application of the Pediatric Assessment Triangle (PAT), a tool to help EMS practitioners rapidly and accurately assess pediatric patients.



**GERIATRIC EDUCATION FOR EMS** Courses: 436 / Students: 3,595

Geriatric Education for EMS (GEMS) provides EMS practitioners at all levels with the skills and knowledge to address the unique medical, social, environmental and communications challenges of older adults. Developed by NAEMT in partnership with the American Geriatrics Society (AGS), GEMS empowers EMS practitioners to help improve medical outcomes and quality of life for geriatric patients.

#### **PSYCHOLOGICAL TRAUMA IN EMS PATIENTS**

Courses: 158 / Students: 1.360

Through Psychological Trauma in EMS Patients (PTEP), EMS practitioners learn to help alleviate patients' fear, stress and pain, the hidden wounds that can result from a medical emergency. PTEP educates EMS practitioners about the biological underpinnings of psychological trauma, the short and long-term impact on the brain and body, and warning signs that a patient is experiencing extreme psychological distress. Through scenario-based interactive sessions, EMS practitioners are also taught strategies and techniques to alleviate patients' distress and help patients cope with what they're experiencing to ward off lingering effects.

#### **COMMUNITY PARAMEDICINE SERIES**

Courses: 34 / Students: 169

NAEMT's Community Paramedicine course series focuses on the knowledge and skills that paramedics need to succeed as community paramedics. As paramedics are increasingly depended upon to provide preventive as well as emergent and urgent care, these courses are outstanding education for all paramedics. The series is also designed to prepare paramedics to take the IBSC Community Paramedic Certification (CP-C) exam.











## Operational Education



## PRINCIPLES OF ETHICS AND PERSONAL LEADERSHIP (PEPL)

Courses: 40 / Students: 277

Principles of Ethics and Personal Leadership (PEPL) provides EMS and mobile healthcare practitioners with the skills and knowledge to effectively interact with patients and families, other medical personnel, co-workers, supervisors and the community at large. Through course presentations, dialogue, and learning activities, including written and video case studies, students explore the importance of ethics and personal leadership, identify their leadership roles in civic life as individuals, family members, professionals and members of the community, and practice the skills important to the exercise of personal, ethical leadership.

#### **EMS SAFETY**

Courses: 289 / Students: 2,273

EMS Safety teaches students how to protect themselves and their patients while on the job. The course promotes a culture of safety and helps reduce the number of on-the-job fatalities and injuries. EMS Safety is the only national, comprehensive safety course for EMS practitioners. Its interactive format features real-life case studies and compelling discussions on current safety issues, and provides participants with a forum to share their own experiences. Critical thinking stations help build participants' risk assessment and decision-making skills.

#### **EMS VEHICLE OPERATOR SAFETY (EVOS)**

Courses: 811 / Students: 7,882

With a focus on creating a culture of safe driving, EMS Vehicle Operator Safety (EVOS) draws on the most current research about specific behaviors and other hazards that lead to crashes. EVOS features case studies and analyses of both common and catastrophic collisions to challenge EMS practitioners to reconsider their preconceptions about safe vehicle operations. Instructors can easily incorporate local laws, rules and policies into the curriculum.









## Virtual Education



## VIRTUAL REFRESHERS FOR PARAMEDICS, AEMTS AND EMTS

Courses: 71 / Students: 353

The Virtual Refresher series provides EMS training officers and educators with concise courses that meet NREMT's national recertification requirements. The series includes three refresher courses: paramedic (30 hours), AEMT (25 hours), and EMT (20 hours). The refresher courses are designed to be taught virtually, using online platforms such as GoToMeeting, Zoom, Webex, Skype, or other virtual instructor-led training (VILT) platforms.

#### **RECERT**

Recert offers over 200 online learning modules covering a wide range of topics in EMS, including trauma, stroke, shock, infection control/PPE, pediatrics, safety, psychiatric and behavioral emergencies, pharmacology and special patient populations. NAEMT's evidence-based education content is used extensively in Recert learning modules. NAEMT partners with the Public Safety Group of Jones & Bartlett Learning on Recert.

## Bystander Education



#### **FIRST ON THE SCENE**

Courses: 295 / Students: 3,790

First on the Scene (FOTS), developed by NAEMT and the International Association of Fire Chiefs (IAFC), provides instructors with a toolkit to teach the general public basic emergency response to life-threatening emergencies until EMS arrives. The course covers hands-only CPR and AED, administering naloxone and epinephrine auto-injectors, stopping life-threatening bleeding, penetrating chest trauma, moving patients to safety and positioning injured patients.

## NAEMT Instructor Preparation Course

The NAEMT Instructor Preparation Course is a prerequisite for any EMS instructor who wishes to teach NAEMT courses. In 2022, 3,672 instructor candidates took the course, which is offered online in English and Spanish, and as a classroom course in other languages.

### Affiliate Advisory Council Meeting and Luncheon


