My name is Louis Imperatrice and below you will find my candidate background information for the position of East Central Regional Director.

I have been a paramedic since 2010 having obtained my National Registry of Emergency Medical Technicians Paramedic and New Jersey Mobile Intensive Care Paramedic license in February 2010. I have been a full time paramedic in New Jersey from 2010 thru 2021 and currently practice as a per diem paramedic in New Jersey. I also hold paramedic licensure in the Commonwealth of Pennsylvania and State of Texas.

Currently I serve in the full-time role as National Manager of Clinical Excellence with DocGo, a multifaceted mobile health and EMS agency with EMS operations in 8 US states. In my role, I oversee all clinical EMS education and quality improvement for BLS, ALS, and critical care transport. This role includes serving as an NAEMT instructor and faculty for PHTLS and AMLS as well as a course coordinator for all education courses offered by the NAEMT.

I graduated from the NAEMT's Lighthouse Leadership Program in September 2024 under the mentorship of Chris Le Baudour and will be serving as a mentor in the 2026/27 cohort of the Lighthouse Leadership Program.

I have lectured both locally and nationally on various topics in EMS leadership and EMS education including at the Pennsylvania EMT conference, National Collegiate EMS Foundation National Conference and EMS World.

In additional to serving as a course coordinator, instructor, and faculty for the NAEMT, I am an American Heart Association instructor and faculty for ACLS, PALS, and BLS as well as an instructor and faculty for Advanced Stroke Life Support.

I currently serve as state faculty for the NAEMT for PHTLS & AMLS. I am an NAEMT instructor and actively teach PHTLS, AMLS, TECC, AHDR, EMS Safety, PEPL, PTEP, EVOS, Breaking Bad News, Community Paramedicine Series, NCCP Refresher Series, EPC, GEMS, and MHRO.

I am a regional course director and instructor for The Difficult Airway Course: EMS and have taught and coordinated many Difficult Airway Course: EMS course throughout the East-Central Region.





I also maintain my NAEMSE Level 1 instructor credential and as well as my Pennsylvania EMS-Instructor license.

In 2023 I was nominated for both the New Jersey EMS Educator of the year and the Jones & Bartlett EMS Educator of the Year.

In addition to my many roles as an instructor, I have published several articles in the Journal of Emergency Medical Services (JEMS) on EMS education and EMS leadership. (see attached articles).

I maintain employment on a full-time basis as the National Manager of Clinical Excellence with DocGo as well as a per diem 911 paramedic with Hackensack Meridian Health – JFK EMS, for which verification letters are attached.
