Welcome members and guests to the 2022 NAEMT General Membership Meeting! We are grateful and honored to have so many of our members and friends with us this evening. This meeting marks the last time I will be with many of you as your President but my service to you as members will continue. I am so grateful to have witnessed firsthand the enthusiasm and commitment of so many of you and other NAEMT members to the priorities of this great association that are helping to advance our profession. I came into this position two years ago with big ideas – a lot of them – and much to my surprise, many of them came to fruition. I appreciate every effort toward the strides we've made!

In the next hour or so, we will celebrate the accomplishments of our association and recognize the very best in our profession.

Before we begin, please rise as we renew our commitment to our nation and the communities, we serve by reciting our Pledge of Allegiance.

Thank you.

Although many of our members wanted to be with us in Orlando, they instead are responding to the needs of their communities, and/or responding to disasters. They are still with us in spirit, and we send prayers for their safety and wellness.

Also missed are the many colleagues we lost in the line of duty...from crashes... to shootings... to violence... We must honor and remember our brothers and sisters for their sacrifice. We owe it to them to do everything in our power to make sure that communities and elected officials recognize their sacrifice and provide EMS with the resources needed to protect our workforce.

In July, the National EMS Memorial Service was held in Arlington, Virginia, to recognize and honor the sacrifices of the 2022 honorees who died in the line of duty. The NAEMT Board attended the Service to honor our fallen and their families.

To pay tribute to those brave Paramedics and EMTs who made the ultimate sacrifice in service to their patients during that time, Jana Williams from the National EMS Memorial Service will lead us in a prayer for our fallen heroes.

Thank you, Jana. These EMS heroes will never be forgotten. Their sacrifice inspires us to make our EMS profession better — and safer — for our practitioners and for the patients we serve.

And now, I am pleased to provide an update on the work that has been accomplished on behalf of our members and to advance our profession.

Let's start with Advocacy. NAEMT has been actively advocating for laws to help EMS agencies and personnel recover from the pandemic and build back their resiliency.

Our priority issues include:

- Increased funding for the SIREN Act to support rural EMS agencies.
- Protecting Access to Ground Ambulance Medical Services Act to extend the ground ambulance addon payments until Congress can complete the cost collection process.
- EMS Counts Act of 2021 to ensure that the EMS workforce is accurately counted by the federal government.
- Funding for EMS workforce development to counteract the crisis-level shortages communities are experiencing across the country.

In response to the personnel shortages that our agencies are facing, NAEMT's EMS Workforce Committee collected some best practices and successful case studies which were compiled into a new guide on *Innovative Recruitment Strategies for EMS Agencies*.

NAEMT is also facilitating an initiative with seven other national EMS organizations to develop a national guidance document on minimum staffing of EMS personnel for different types of 9-1-1 medical calls and scheduled interfacility transports. We envision that this guidance document will be used by state EMS offices when considering revisions in their state's regulation of EMS and by agencies to determine the optimal staffing configurations to support quality patient care, efficient operations, and practitioner safety.

Through published comments and positions NAEMT continues to speak out on important issues for our profession and our patients. So far this year...

1. We provided comment to NIOSH – the National Institute for Occupational Safety and Health – on the need to establish Personal Protective Technology Centers of Excellence to conduct research and identify practice gaps.

- 2. We signed onto a joint letter to Congressional leaders requesting additional funding for ground ambulance services and an extension on the 2% sequestration cut moratorium on Medicare providers and suppliers. We later requested that Congress extend until the end of this year a moratorium on the 1% sequestration cut to Medicare providers and suppliers scheduled to take effect on July 1.
- 3. We issued a Statement requesting urgent attention to the crisis-level shortages of EMS personnel in preparation for a hearing by the Senate Subcommittee on Employment and Workplace Safety.
- 4. NAEMT adopted a new position calling for the U.S. Department of Defense to implement a program to ensure that all military medics, Corpsmen, Special Operations medical providers and military EMS/Fire service providers maintain a certification through the National Registry of EMTs.
- 5. We partnered with 13 national and international associations on the release of a Joint Statement on Lights and Siren Vehicle Operations on EMS Responses.
- We provided Comment to the HHS Office of the Assistant Secretary for Preparedness and Response on the National Health Security Strategy for 2023-2026.
- 7. We signed onto a joint letter to leaders of the U.S. Senate and House Appropriations

 Committees recommending funding in 2023 of \$20 million for the SIREN/ Rural EMS Training and

 Equipment Assistance program to meet the critical need of EMS in rural areas.
- 8. We also submitted written testimony to the House Appropriations Subcommittee on Labor, Health and Human Services, Education and Related Agencies requesting increased funding for SIREN grants, and EMS access to federal grant programs to support apprenticeship programs and workforce development programs.
- 9. Another joint letter was sent to leaders of the Subcommittee on Labor, Health and Human Services, Education and Related Agencies requesting \$28 million in funding for the EMS for Children program at the Health Resources and Services Administration.
- 10. Our letter to U.S. Senate and House leaders requested Congress to bring the Post-Disaster Mental Health Response Act up for a vote as soon as possible.
- 11. In a joint letter to the Department of Transportation, we shared concerns over the crisis-level availability of ambulance chassis which impact the delivery of all ambulance services nationwide.

- 12. We provided comment on NREMT22-Resolution regarding paramedic program accreditation, and updated our position statement on program accreditation.
- 13. We issued a public statement to NHTSA to request funding and rulemaking in the National Roadway Safety Strategy.
- 14. And, we continued to represent EMS practitioners on the Medical Preparedness Forum of the National Academies of Science, Engineering and Medicine. The Med Prep Forum brings together the very top experts in national medical preparedness to provide the federal government with recommendations to improve our country's ability to respond to disasters and public health crises. This year, we expanded our engagement with the National Academies by joining its Traumatic Brain Injury Forum. This new forum is looking at advances in science, technology and practices to improve TBI patient outcomes.

To assist NAEMT members and the broader EMS community:

- NAEMT published a report on the results of a National Survey on EMS Utilization of CMS Waivers
 During COVID-19 to understand how ambulance services are utilizing waivers provided by CMS
 during the COVID-19 public health emergency.
- 2. In partnership with the American College of Obstetricians and Gynecologists, NAEMT reported survey findings indicating that many EMS practitioners don't feel they have adequate education or training to respond to emergencies in pregnant and postpartum patients.
- 3. NAEMT published a new vaccine toolkit that can be used by EMS agencies to help local public health officials understand how EMS can support local vaccination efforts. Titled "EMS: A Valuable Resource for Community Vaccination Campaigns" the toolkit details the attributes that make EMS agencies, and the paramedics and EMTs who provide clinical care an ideal resource for vaccination initiatives.
- 4. We also hosted our second virtual **EMS On The Hill Day** on April 4-8, drawing 312 registrants from 49 states, the District of Columbia and Puerto Rico. It was the largest Hill Day event to-date with 241 meetings held with U.S. Senators, Representatives and their staff to discuss key EMS issues.
- 5. We partnered with ACEP to promote the 47th annual **National EMS Week** on May 15-21. This year's theme, *EMS: Rising to the Challenge*, highlighted the important contributions of EMS practitioners in safeguarding the health, safety, and well-being of our communities. During the week, we highlighted EMS agencies and practitioners across the country. We provided gifts of appreciation to our individual and agency members. In honor of Health, Wellness and Resilience Day, we offered 50 scholarships for NAEMT's Mental Health Resilience Officer course, generously sponsored by FirstNet®, Built with AT&T.

- 6. NAEMT launched the Lighthouse Leadership Program a new mentorship program for EMS practitioners. Participants are selected annually and matched with EMS leaders who possess the specific knowledge and experience to guide mentees in developing a personal career strategy. They also provide action steps for the mentee to achieve his or her career goals. It is an 18-month mentorship provided by highly credentialed, well-respected EMS leaders. Some of our mentees are with us this evening and are wearing name badges identifying them as program participants. If you see them, I encourage you to ask them about their mentee experiences. Our first class of mentees will complete their program next September. We will be selecting our next class of mentees in early, 2023.
- 7. We conducted a national survey on EMS personnel perspectives on workforce engagement and satisfaction. We are in the process of preparing a national report on the survey results which will be shared with our members and distributed to EMS employers. We expect that this report will be published by the end of the year.
- 8. And, at our last Board meeting, we agreed to explore how NAEMT might identify and recognize mental health providers who specialize in caring for EMS personnel. We have heard our members tell us that it is very difficult to obtain mental healthcare from providers who understand the level of stress and exposure to trauma that we encounter every day. We hope to find a method for identifying those mental health providers who can give us the care we need.

Now turning our focus to education...

NAEMT faculty, authors and medical directors have continued to work to provide our workforce with the very best continuing education available. We deeply appreciate the great efforts and work of our global faculty. Here are our accomplishments to date:

- 1. With support from FirstNet[®], Built with AT&T, NAEMT launched the new Mental Health Resilience Officer MHRO course to assist EMS agencies in building and supporting the mental health resilience of their personnel. The course was first available as an online course through our publishers, but it is now available as a classroom course. The inaugural course was conducted yesterday here in Orlando, and it will also be offered at the Texas EMS Conference next month. The course will be available to all training centers in January.
- 2. We released the **new!** EMS Safety 3rd Edition provider course. This award-winning course provides essential training to EMS practitioners to keep them safe on the job. The course was conducted earlier

today and received great response. You can visit the NAEMT website to learn more, locate a course, or view the requirements for becoming an instructor.

- 3. We published the 10th edition PHTLS textbook and conducted the PHTLS instructor update yesterday for PHTLS faculty from around the globe. The release was much anticipated and very-well received. Thank you to our Prehospital Trauma Committee and author team for this outstanding achievement.
- 4. We are finishing up the 3rd edition of our **Geriatric Education for EMS** GEMS course and the 2nd edition of our **All-Hazards Disaster Response** course. Both courses will publish in the first half of 2023.
- 5. Earlier today, we held the 11th annual World Trauma Symposium, attended by over 300 registrants both here in Orlando and by live-stream around the world. I want to thank Dr. Warren Dorlac and CPT. Meg Morgan for moderating the program and the presentations by more than a dozen trauma care and research specialists. The program was outstanding!
- We also continue to offer our members FREE CE webinars presented by top EMS experts in the country.
 - This year, we conducted a series of three webinars in collaboration with NAEMSP on managing agitated patients, implementing a whole blood program, and standards of care in prehospital airway management.
 - For our instructors, we conducted a series of webinars on best practices in patient simulations.
 - In collaboration with the Public Consulting Group, webinars were held on preparing for grant opportunities, and determining the worth of your ambulance service.
 - Other webinar topics included case studies in prehospital stroke management, and safe and appropriate use of lights and sirens.
 - Two more webinars are scheduled for this year. One for agency managers focused on how to engage your workforce, and a special webinar that will bring together experts in running local and state campaigns for elected office to help EMS professionals learn how to successfully run in a local or state election.

All of these webinars are available on demand for our members through the Member Portal
on our website.

NAEMT awarded \$25,000 in EMS scholarships to members to help them advance their careers.

- In partnership with Columbia Southern University, a scholarship worth up to \$13,000 was provided to an NAEMT member.
- NAEMT and the NAEMT Foundation awarded 11 scholarships to attend EMT school.
- All NAEMT scholarships are needs-based to help those who want to enter or advance in our profession.

NAEMT also rolled out new member benefits, including:

- Minimum \$120 savings on processing fees and free consultation for U.S. federal student loan repayment options from The Student Loan Help Group
- 30% off the web price on the entire product line of Lenovo
- Up to 50% off global parcel delivery services to include specialized transportation and logistics services and solutions from United Parcel Services (UPS)
- New travel discounts, including car rentals, hotels, airfare, and travel and vacation packages.
- This year, we also held virtual listening sessions to allow members to share their thoughts, ideas, and
 concerns with their regional directors. In addition to regularly surveying our members, we will continue
 to offer listening sessions in the future as another way for members to connect with their elected
 Board.

These are just some of the highlights of the tremendous work being accomplished by the hundreds of members who volunteer their time to these projects and keep our association moving with forward momentum. The active engagement of our members is NAEMT's greatest asset. With your continued support, we will continue to advance the EMS profession. It is my honor to serve you. SUSAN:

Roxolana has been working with the Ukrainians since 2014, when the first war broke out. She introduced TCCC and PHTLS into Ukraine. When the most recent invasion began last

February, she immediately started to plan for Stop the Bleed training for civilians and NAEMT courses for first responders, medical providers and military personnel.

The needs of the Ukrainian people are immense. The suffering is horrific. But it is amazing what one person can accomplish. Thank you, Roxolana, for all you have done for Ukraine and its people.

Sergeant Williams is an Independent Duty Medical Technician serving as an Education and Training Specialist with the 673d Medical Group at Joint Base Elmendorf-Richardson. He is responsible for training 1,700 military medics, nurses, and other prehospital providers on advance medical skills. Serving in the Air Force for 17 years, he has deployed six times, including two combat tours to Afghanistan, serving as the sole medical provider. He directly cared for more than 150 patients in care-under-fire events and mass casualty situations. His critical thinking, rapid field assessments, and combat training enabled him to perform several surgical airways and needle decompressions, and numerous tourniquet applications to patients with multisystem traumas. He also taught a Combat Lifesaver Class to students in the Afghan National Police, Afghan National Army, and National Directorate of Security. For his distinguished service as both a combat medic and medical project manager, he was awarded the Bronze Star Medal, Air Force Combat Action Medal, and the Army Combat Medical Badge. He has helped to expand and promote Tactical Combat Casualty Care in Alaska and Germany. He was also key in the advancement of the Below Zero Medicine concept, and development of the course curriculum in support of the National Defense Strategy.
